1) To All Concerned in the Matters of my ^{RESU} 16
Children and Neal's Children, Cory Grant Creamer,
and Skyler Creamer-Setz, I am writing
this statement in order to clear up any
lies or rumors being said on behalf of
the TRUTH of the situation our family
has found ourselves in here in Geneva
Switzerland.

First and foremost the decision to
move our family here was a mutual one between
Neal and I, Cortni Heler Creamer. It was our
hope that by coming to Neal's dual citizenship
and Skyler's here in Switzerland, and
Neal's mother's birthland, we could make
a better life and a SAFER life for our
children. In America, particularly Arizona, where
we met, married, and raised our children,
we struggled constantly against the strict
religious group of which I was a part of and
my family. My mother had ~~been~~ married an

influential leader and great grandson in the Mormon church and therefore her beliefs and my families' influenced my little family to the greatest degrees.

Neal did not grow up Mormon but because he loved me he joined the church knowing I wouldn't marry him nor would my family approve of him if he hadn't. However, despite joining the church my family still despised Neal because he learned quickly of all the abuse I was subjected to in my family and he was openly opposed and vocalized his disgust regarding the treatment of me and even my nephew Austin Grant Creamer Bradford whom my mom had taken from my sister and adopted. My family, in particular my older brother Damian Parnell Creamer arrased and hacked Neal's ~~only~~ sources of income to support our family. My brother Damian Parnell Creamer was upset that Neal

I knew about him abusing me and my sister
since the time we were infants along with
my real father who died when I was 16 yrs old.
My sexual abuse from my brother Damian
Pamell Creamer put a difficult strain on
our marriage due to my PTSD and nightmares
and lack of trust. I went through the same
problem with my first husband Kerry.
Neal and I were hoping that by making half
way across the world and away from my
family we would be able to get some
distance and in depth counseling for my
trauma and the more recent traumas of
my family harassing Neal and I. Neal and
I both witnessed my little nephew Austin
whom I considered like my own son multiply
abused physically by my mother Helen Mai
Bonitzke Creamer Bradford and her husband
Robert Grant Bradford. We called CPS and
the police throughout the years to no
avail until I accidentally came across a

video made by my mother Helen Bradford
of my step-dad, her husband, Robert
Bradford, sexually abusing my nephew
Austin in a bathtub in a hotel in
Tucson AZ. It was this video that Neal
and I both turned over to the police that
finally rescued my little nephew from
sexual abuse. Not coincidentally Austin had
tried to tell people he was being sexually
abused years before and my parents accused
Neal of it in order to avoid prosecution.
Of course though the police found Neal
not guilty or had any reason or need to
make a report. My family continued to
accuse Neal of abusing my nephew and
spread rumors throughout AZ and Neal's
business that we eventually were
struggling socially and financially everywhere
we went. Finally when the proof of my
parents sexually abusing Austin came to

light, the damage to our family was already done and we needed a new start and a new beginning. This was why we came to Switzerland. My brother Damian who sexually abused me (and I have openly discussed with therapists since I was 18 yrs old) still remains a free person and my parents hired the best defense attorneys with the Mormon Church and Brad's influence to get off of spending any jail time, however, Austin was permanently removed and placed in a new family.

Neal and I have done nothing but try to protect our children from my family and be the best parents we could be despite all our obstacles. In the end we felt afraid and every where we turned my stepdad, mother, or brother Damian was spreading rumors about Neal and hacking his ~~ISSUES~~ ISSUES. This is why we came to Geneva

where we were planning to get remarried
and raise our little family peacefully. However,
once we arrived here things unfortunately did not
go as smoothly as we hoped and due to
my own trauma of ~~being~~ 1st witnessing
on video my nephew being raped and being
in a foreign country where I did not speak the
language I made the wrong decision by drinking
alcohol to numb my pain and fears. Neal was
against this and consequently it led to a fight
and me being suicidal. However I was not
in any way shape or form under the idea that
would ever hurt one of my own children
I clearly in the video made a statement
that I could for the first time understand
why there are mothers who have been so
depressed and have unfortunately done that. Despite
Neal and I struggling Neal has always been a good
SAFE and Responsible parent and our children
love him dearly. He has dedicated his life to being
their father and he is a good loving dad. I Pray this
learns up the lies on my behalf he is a good person. Sincerely
