She spent most of last night and the morning in the hospital for severe dehydration after being denied drinking water and food for at least 2 days while living in the above mentioned residence. She received 3 bags of fluids and is now staying in a safe woman's shelter. The truth about this entire story will come to the light. I would ask that all concerned about how children get taken from their families at a hospitals bidding

and all the other Networks of people involved in that process, would continue to pray for the exposure necessary to put a stop to it. Jaxon Adams is thriving and doing well without all the medical treatment the Hospital (CHILDREN'S MERCY HOSPITAL) had initially prescribed. What makes it worse is our visits were scheduled for Monday nights and right before we left him Monday night he asks us to give him 7 hugs and 7 kisses enough for the week.

Just when you think it can't get any worse. I've now lost my business that I've ran out've our home for 7.5 years due to the backlash of CPS and the damned hospital that falsely accused us of all the awful things. This has completely devastated our family on so many levels only few know. Finding a job in what I have experience in is not possible at the moment because of the pending allegations.

What's worse I am just a few credit hours short of being a RN and if we're convicted of any of these allegations I can not complete my degree. Which in turn means I will have over 45k in wasted student loans I have to repay. We have been silenced in fear for long enough.

Our story needs to be heard. Jaxon's story need to be told. He was not EVER an abused child. He was a child that should still be in his home. He was a happy ,well adjusted little boy with a ton of medical issues. Please share our story near and far. It needs to be heard.

A Missouri doctor allegedly told a little boy that, if she had it her way, he would never see his mommy and daddy again. This was after 8 year old Jaxon was seized from his parents' custody based solely on a statement from this single doctor, according to his parents. His parents, Tiffany and Jason Adams, are desperately trying to bring him home after what they believe to be his doctor's retaliation because they

“dared to seek a second opinion.”

It used to be that patients and parents were not only permitted, but encouraged to seek a second opinion. It used to be that parents and patients had the right to fire one doctor and hire another one. It is unclear how or when those sacred rights vanished, but vanished they have apparently for one family who has been devastated by the severity of retribution when they sought those very things. An 8 year old little boy is reported to be left traumatized and confused, because his family has been ripped away from him by Children’s Mercy Hospital in Kansas City, enabled by Child Protective Services.

Jaxon Adams’ Story

I recently interviewed Tiffany Adams to learn Jaxon’s story.

Affectionately known as Jaxx, adorable Jaxon Adams was a pretty healthy baby – babbling, sitting up, and meeting all the normal milestones. His 6 month shots were delayed because of an ear infection, but he got all of his routine shots at 8 months. He slowed down somewhat after that, but nothing seemed really concerning.

When he was four, his parents noticed that he had a hard time keeping up with his teammates on the soccer field. A teacher recommended an evaluation. Jaxon was diagnosed as being on high-functioning end of the autism spectrum, as well as having ADHD.

He began to have seizures, and was diagnosed with epilepsy. He struggled with constipation, low energy, and sleeping much more than normal. Testing revealed a number of food allergies, some of them severe. His parents and doctors

worked hard to find medications and foods that his body could tolerate. Eventually, doctors decided to surgically insert a g-tube feeding tube into his stomach.

Beginning Treatment at Children's Mercy Hospital

After all that, Jaxon was struggling to gain any weight. His parents wanted to find out why. In March of 2014, the Adams began to see nurse practitioner Ingrid Larson in Dr. Amber Hoffman's practice at the Beacon Clinic in Children's Mercy Hospital. Unbeknownst to the Adams, the [Beacon Clinic](#) is where a doctor later allegedly told a source that children suspected of being abused are "funneled into."

During this time, Tiffany states that another doctor noted that some of Jaxon's symptoms could be caused by mitochondrial disease, but he told Tiffany that Children's Mercy Hospital was very poor at diagnosing it. He recommended a doctor at Cardinal Glennon, who became convinced that Jaxon had a mitochondrial condition after running two tests. Before running the third test he scheduled in June, he abruptly cancelled and said he didn't want to be involved with Jaxx's care, after a conversation he had with Dr. Hoffman's office.

Questioning Inferior Treatment at Children's Mercy Hospital

In August, Tiffany, says she and Jason met with Jaxon's care team at Children's Mercy Hospital's Beacon Clinic. They shared their concerns about the care by the nurse-practitioner regarding Jaxon's weight issue. Under the nurse's care Jaxon had lost quite a bit of weight. But when Tiffany began researching natural foods and changing his

diet, he began to put on weight again.



When the nurse told Tiffany that she couldn't figure out why he hadn't been gaining weight, Tiffany said that they would be looking for someone who would be able to figure it out.

The parents had begun speaking with a medical malpractice attorney, who started looking into Jaxon's medical records.

It was right after this that the little boy began fainting.

Tiffany said that he just passed out just a few feet in front of her while he was riding on an electric scooter, an accident that landed him in the hospital with a cut above his eye. Once he fainted while eating birthday cake at a party. While Jaxon's parents were puzzled about the fainting spells, the doctors at the Beacon Clinic allegedly decided that they were psychosomatic. They also told the parents that **all** of Jaxon's problems were in his head.

Doctor Threatens Parents at Children's Mercy Hospital

When the Adams said they wanted to get a second opinion, they were reportedly told that they were not allowed to do so. When they suggested switching pediatricians, again the Adams were told that they could not.

On September 15, the family had an appointment with Dr. Hoffman at the Beacon Clinic. The doctor reportedly came in and asked why they disagreed with the diagnosis of psychosomatic causes for Jaxon's multiple conditions. According to Tiffany, the doctor's hostile attitude became upsetting to her son, and he was removed to a waiting room. The Adams insisted that they had a right to seek another opinion. To which Dr. Hoffman allegedly replied:

"I want you to know big hospitals take kids away from families for this stuff."

Tiffany asked, "For seeking a second opinion?" When the doctor nodded yes, Jaxon's mother asked, "Why would you do that to me?"

Mrs. Adams says she heard vengeance in Dr. Hoffman's response: "I hope you have a good attorney. We're going to have your behind."

CPS Unwillingly Takes Custody Under Doctor's Orders

Two days later, on September 17, Child Protective Services showed up at the Adams home with a police officer to talk to them. A therapist who had arrived just before to help with Jaxx's care told Tiffany, "I cannot believe this. You guys are GOOD parents." When they left, they said they would be back soon to get the kids. They also said they couldn't tell what the accusations were against them. One of them told Tiffany, "You guys are not bad parents."

They returned on the next day to take Jaxon away from his home, from his parents, and from his 10 year old sister, who he is very close to as well. He was taken to Children's Mercy Hospital, and not allowed to see his family.

The investigator had tears in her eyes when she admitted that she did not want to take Jaxon, "but they're making me." It came down to one statement, with no charges being filed, and CPS admitting that they had not reviewed the medical records. Dr. Hoffman had called CPS immediately after the meeting with the Adams where they asked for a second opinion.

The doctor reported to CPS that Jaxon was in "imminent danger," because his organs were at risk of shutting down because he wasn't getting proper nutrition at home. She said that they had been building a case against them for six

months, and that they had all the evidence they needed.

Later, Jaxon's parents learned that they stood accused of medical abuse, medical neglect, lack of nutrition, lack of supervision (based on him falling off the scooter when he fainted, although Tiffany was right there when it happened), and psychological abuse.

Children's Mercy Hospital Terrorizes Family

The real psychological abuse took place as soon as Children's Mercy Hospital got Jaxon under their care. His parents were allowed a brief 25-minute visit shortly after CPS took him. It would be 26 days before the system would allow this little boy to see his parents again.

Dr. Hoffman came into the child's room when he was crying his heart out missing his family. She told him to suck it up and stop crying. Her words that she told him were cruel beyond belief, as he later confided to his sister:

"If I have it my way, you'll never see your mommy and daddy again."

Because Jaxon tried to call his parents, the staff took the phone out of his hospital room.

A couple of times, he got out of his room heading for the stairwell, in a vain attempt to escape.

There were signs on his door saying, "Under CPS custody," and "Parents Not Allowed In." As his mother says, "He can read."

He later told his family that he cried a lot because he didn't know where his family was. He felt utterly abandoned.

Tremendous Abuse and Suffering Under Hospital Care at Children's Mercy Hospital

The hospital has been feeding him foods that Jaxon is allergic to according to the parents, resulting in his being covered in eczema.

The care plan called for "demedicalizing" him, taking him off of all the medications the doctors had previously prescribed, cold turkey. Interestingly, over the course of the next few weeks, they allegedly ended up re-prescribing every single prescription except the seizure medicine.



They reportedly took away the wheelchair and threw away his leg braces that he used because of his hypotonia and often severe leg pain.

When his parents were finally able to visit him on October 13th, after nearly an entire month, Jaxon didn't want to let go of his mommy.

Jason and Tiffany were instructed not to discuss anything that had happened with him. This reportedly frustrated Jaxon, who couldn't comprehend why they kept changing the subject. He wanted to know why they were ignoring him. He cried out in exasperation, "I'm not done telling you!"



Parents Restricted Visitation Rights – Transferred to Foster Family

The Adams say they have only been able to visit their son once since that visit. They are now permitted one two-hour

visit per week.

He is out of the hospital now, and in the care of foster parents. His sister has reportedly been permitted to visit him on several occasions. Because he no longer has the leg braces, there are times that Jaxon literally crawls around the house, because his legs hurt. The foster parents have allegedly been instructed to ignore any pain that he has. They say that they are forbidden to give him as much as a Tylenol for pain.

Jason Adams, the father of Jaxon, told me this:

Tiffany especially, as a stay-at-home mom, has gone above and beyond. There's nothing you can do about it, and that's probably the most difficult. My family means the world to me and I love them. You live in the United States of America, and in this particular court setting, you're guilty until proven innocent. He was taken away with no just cause.

Dr. James Anderst – Spy Doctor & Expert in Munchausen Syndrome by Proxy

Since Jaxon's abduction, a couple of disturbing things have come to light. The Adams have discovered that [Dr. James Anderst](#) has been working behind the scenes watching Jaxon for several months.

Dr. Anderst is the Division Director of the [SCAN clinic](#), a division of Children's Mercy Hospital. In one place on the hospital website, the clinic carries the description, "[Safety Caring and Nurturing Clinic](#)," but in another place, its real purpose is revealed as the "[Child Abuse and Neglect Clinic](#)." He reportedly told a source that, before a child becomes a part of that clinic, families that they want to watch are

“funneled into” the Beacon Clinic for observation.

According to the Children’s Mercy Hospital website, the [SCAN clinic is also a research center](#) for “child abuse and neglect.” Dr. Anderst is associated with the University of Missouri Kansas City School of Medicine, which receives [over \\$47 million per year in grants](#) to do drug research.

Jason Adams, the father of Jaxon, states: “Dr. Anderst gets grant money to do this to 40 families a year.”

The [Beacon Clinic](#) is allegedly often presented to the unsuspecting parents of special needs kids as a place where they can go to coordinate care and be seen quicker, with a more streamlined process. They may have no clue that as the Adams family reported, someone may be watching them.

In a startling alleged comment to *Health Impact News*’ source, Dr. Anderst declared that he sees about 40 cases per year, in Kansas City alone, of Munchausen syndrome by proxy, a type of child abuse where a parent seeks attention by inducing real or imagined medical symptoms in a child. Most experts maintain that the syndrome is extremely rare. Nothing in Jaxon’s story seems to read like Munchausen’s according to the parents.

Yet, it appears that he is determined to make this accusation against Tiffany Adams, a mother who has simply followed the instructions of her doctors, to the best of her ability, until it became clear that another opinion was needed. By daring to contradict her son’s almighty doctor in search of answers and better medical care for her child, she is being punished in the cruelest way possible. Jaxon just wants to come home. He desperately misses his family. And they are devastated by his absence.

As the Adams family continues to struggle to get their son back from the state of Missouri, they are reaching out to the public and to the media in the hope of exposing the tragic reality that far too many people are facing when they simply seek a second opinion or better medical care for their beloved child.

Parents face daunting custody battle with the State of Missouri after their child was medically kidnapped by a local hospital Independence, Missouri, February 25, 2015:

The Adams family is yet another family that has fallen victim

to the disturbing trend of “medical kidnapping” which is occurring across the United States. Medical kidnapping is a term used to describe children being taken into state custody after parents disagree with a course of treatment recommended by a doctor, or in the case of the Adams seeking a second opinion and/or a change in medical care. Upon being informed of the same, the physician then places a “hotline” call to child protective services and reports “medical abuse” by the parent.

These physicians frequently allege that one or both of the parents suffer from Munchhausen’s by Proxy also known as Factitious Disorder Imposed On Another (“FDIOA”), a mental illness whereby a caregiver fabricates symptoms of illness in another under their care (i.e., children, elderly adults, disabled persons, etc.). FDIOA is a diagnosis made upon the parent and/or caregiver, not the child, and it is difficult to diagnose and often requires prolonged evaluation of the individual allegedly suffering from the disorder. In medical kidnapping cases, it is a doctor at the children’s hospital attempting to affix this FDIOA label to the parents and in many cases the doctor attempting to do so has never met the parents of the child, as is the case with Jason and Tiffany Adams.

The Adams’ son, Jaxon, was taken into state custody on September 17, 2014, after doctors from Children’s Mercy Hospital placed a hotline call alleging Jaxon’s parents were medically abusing him. Jaxon had been under Children’s Mercy Hospital’s care for a number of years. In July and August of 2014, the Adams were becoming more and more dissatisfied with Jaxon’s medical care and sought to transfer his treatment to the University of Kansas Medical Center in addition to changing his primary care doctor. However each time the parents attempted to remove Jaxon from care at Children’s Mercy Hospital, the new physician would receive a

phone call from one of the Children's Mercy doctors and the new physician would refuse to treat Jaxon. Jaxon's parents followed the recommendations of the physicians at Children's Mercy and based upon physician recommendations, Jaxon underwent a number of procedures and tests.

The physicians now claim that the tests and procedures were "unnecessary" yet admit that the physician ultimately has the final decision as to whether a procedure is performed. So now the Adams find themselves in the position of having to defend themselves for medically abusing their child when all they did was comply with physicians' advice. Not only did the Adams' fall victim to the physicians at Children's Mercy Hospital; however, they have also been savagely victimized by the Children's Division of the State of Missouri Department of Social Services. They have suffered countless indignities, they are not allowed to talk to their son or Skype with him, and on a number of occasions they have not been allowed to visit their child. In the month of February, they have only seen their child one time using only two units of the twelve units allotted.

As a result, Children's Division is in violation of a Court Order with regard to visitation. The situation with Children's Division has devolved to the point where the Adams have requested that the Missouri Department of Social Services do an investigation as to how their case is being handled as well as how cases are being handled in Jackson County, Missouri.

Jaxon's parents, Tiffany and Jason Adams, were recently interviewed for a segment on 41 Action News Kansas City about Isaiah's Law – a bill named for Isaiah Rider, another Missouri child who, like Jaxon, was medically kidnapped by the state when his parents sought a second medical opinion.

Family Fights for their 5 Children Medically Kidnapped in Missouri

December 21st, 2014 Rebecca Wanosik was blessed with her 5th child. A beautiful baby girl was born in her home in Lebanon, Missouri. It was an uncomplicated home birth, and she was assisted by her midwife. This was Rebecca's 2nd home birth, and with Rebecca being an experienced mother of 4, she knew what to expect. Rebecca and her husband were overjoyed with another beautiful addition to their family. Rebecca had her 4 children prior to meeting Anthony. This was their first child they had together. Rebecca felt so complete with an amazing husband, and now their baby girl.

But soon their family was completely torn apart when CPS came in and took all 5 of their children away, after the baby was found with fractured bones. Being now listed as "child abusers," Rebecca would later learn that she had Ehlers-Danlos Syndrome, with low vitamin D levels for both her and her baby.

Baby's Health Problems Surface

Anthony, Rebecca's husband, has been actively serving in the military for the last 6 years. While he was serving our country, things started to unravel at home.

Rebecca started to feel her daughter's rib cage popping and cracking at 3 weeks of age, so she made an appointment with their pediatrician. She expressed her concern to the doctor,

and the pediatrician said “keep doing what you are doing, she seems fine.” Rebecca went home as advised, and trusted the doctors with their examination

But by February 24th there was discomfort in her daughter’s right arm, and it seemed to be bothering her. Again she made an appointment with the pediatrician. Unfortunately, this time their normal pediatrician was unavailable. Rebecca was concerned, but she took who was available to have her daughter checked out again.

This appointment was different.

After testing, Rebecca was hopeful for answers to what was going on with her baby. She waited patiently. Then more testing and waiting, until finally she was told her baby had multiple fractures and her right arm was broken.

Rebecca knew something must be wrong with her health for this to happen. She knew what kind of mother she was and what an amazing husband she had by her side.

Child Protective Services were called in to investigate possible abuse. Rebecca understood that, and was very

honest and considerate through the questioning process which was quite intense.

Rebecca was questioned several times about her husband, asking if he picked up the baby wrong. According to Rebecca, she was asked, “maybe your husband picked up the baby wrong since this is his first child.”

It was obvious to Rebecca after an hour and a half of her being interviewed that this was more of an interrogation. Her husband even got a letter stating that he was on duty away from home when the injuries allegedly occurred, to show that these allegations couldn't possibly be true. He hadn't even had the chance to be around his daughter very much after she was born.

Rebecca's motherly instincts kicked in again, and she knew she wasn't going to get any help from anyone else. She knew something was wrong with her child and it wasn't abuse.

CPS Takes all 5 Children – Places Them with 11 Other Children and Only 1 Adult

Sadly, all 5 children were removed from the home immediately. According to Rebecca, they were placed in a home with 11 other children and only one adult!

There was no “family preservation screening” done which should have been done within 72 hours. The children could have been placed with other family members, but Rebecca said no one was contacted. There was also a 17 year old in the house where their children were placed. Rebecca felt that there should have been a background check done to ensure the children's safety, but procedures allegedly were not followed.

Searching for Answers

Rebecca started researching, knowing there must be something wrong with her baby – something that she could bring to the doctors and say “this is it.” Rebecca is a determined mom, saying:

“Fighting for your family is not for the fainthearted. It is not for the weak soul, and it is certainly not for the guilty.”

Rebecca was a very disciplined researcher long before this happened. She was not only a hard-working mother of 5, but also working on a dual bachelor’s degree in psychology and human services. She has since switched to criminal justice, pursuing law school.

Rebecca used her research and analytical skills by asking for testing for herself, thinking her vitamin D levels might be low. Since her baby was now in the custody of the State, she thought, “test me for everything that may cause brittle bones in my child!”

Ehlers-Danlos Syndrome Diagnosed

Rebecca’s instincts proved to be correct, and after testing, she was diagnosed with Ehlers-Danlos Syndrome type 3, Hypermobile form. She was severely vitamin D deficient with a level of 5 at ten weeks post-partum.

Ehlers-Danlos syndromes are inherited in the genes that are passed from parents to offspring. They are categorized according to the form of genetic transmission into different types with many features, differing between patients in any

given type. The fragile skin, loose joints, and tissue fragility are often a result of abnormal genes that produce abnormal proteins, producing less collagen. You can learn more about this syndrome here: <http://www.ehlersdanlosnetwork.org/index.html>.

Finally Rebecca had some answers, and took her records to court and to her daughter's doctors. After much pleading, her daughter's vitamin D level was checked, and it was allegedly low at a level 4.31.

Accusations of Abuse Continue

The doctors refused to listen to Rebecca, however, and they allegedly did not believe that her vitamin D levels had anything to do with her daughter's bones. Still being accused of abuse, this threatens not only her not getting their children back, but her husband's job working in the military as well.

This husband and wife team has pressed on, even with a busy schedule. While busy researching their daughter's condition, they have attended everything Child Protective Services has asked them to do. This has included parenting classes, anger management, psychology evaluations and marriage counseling. Even with everything they have accomplished, and with the facts of Rebecca being diagnosed with Ehlers-Danlos Syndrome, they have been placed on the child abuse registry.

Expert Witnesses Called in to Testify

Rebecca has flown to several states with specialists to help prove her child's case, meeting with different doctors and showing medical records to continue to get more answers. At their last trial, they had 2 expert witnesses available by phone to prove their case. Unfortunately, because of the time of the hearing ran so long, the witnesses were allegedly no longer available by phone, and the judge decided to not re-open the case.

One of the doctors Rebecca went to see was in Boston Massachusetts. She provided him with all her medical records and her recent diagnosis. He has agreed to see their daughter.

This will be another battle for Rebecca. How would she get her daughter there? They have been in and out of court with this issue trying to get approval.

Finally, approval has been granted, and the judge has allegedly stated that he would consider reopening their case with the new evidence, depending on what the report from Boston has to say.

Legal Bills Mounting

This is great news, but this has been a long road for this family to travel with mounting bills. There is much more money going out than coming in. Now they have to find a way to continue to pay for all of this.

They started with 1 lawyer and now have 2. They have paid over \$33,000 for all their expenses. Rebecca has been working night and day on research and traveling to gather as much information as possible. Now they are required to pay for plane tickets and a trip back to Boston again. In addition, they must pay for the 2 social workers from Missouri to also travel to Boston, and their rental car, hotel and meals. This couple has endured financial hardship from this case and there is no end in sight. But Rebecca is determined to get her children back.

The parents get to visit with their children 3 times a week, and those visits are the fuel for them to keep fighting. Rebecca's husband continues to fight for our country's freedom, all while their family feels their rights are being violated. Staying strong and focused helps them press on.

Attorneys File Motion on Alleged Rights Violation

Their attorneys have submitted a motion to set aside the order of protective custody. The motion allegedly states that the proper channels were not followed before the judge made ruling for the courts to maintain jurisdiction over the children. As Rebecca states:

“The state violated our right to due process and illegally placed my kids into care without having all the information mandated by law available to them.”

As Rebecca and Anthony continue to fight with many people by their side, they are hopeful their case will be opened once again. They are hopeful that they will be able to prove their baby has a medical condition, and that her condition is in no way related to any abuse.

A Quiet, Empty House

The quiet house is hard to deal with, and Rebecca talks about the memories she holds onto. From the screams of excitement when she picked her children up from school, to the snuggles and wet kisses, and all the joys and hardship of motherhood, she is now left with a broken heart.

Now as their visits are supervised in an unnatural setting, she talks about medical kidnapping.

“Many people think that medical kidnapping is made up and think it doesn’t happen, the truth is that it is very real.”

Rebecca wants people to know this has been a life altering, traumatic experience. Their baby has severe vitamin D deficiency and every one of the stated doctors she has come in contact with has claimed it doesn’t matter in regards to her bone health. She wants people to know this is a long road that no parent should have to travel.

Family Fights for their 5 Children Medically Kidnapped in Missouri

Earlier this month (June 2015) you may have seen [the story](#) we covered on the Wanosik family from Lebanon, Missouri. They are yet another family fighting to get their children back. The Wanosiks are missing their 5 children and are not giving up.

In the [first story](#), we reported how the mother, Rebecca, took

her 2 month old daughter to the doctor for arm pain. She had no idea she would be coming home without her child that day, and that social workers would have their other 4 children taken away for alleged “child abuse.” Read the first story here:

Was Ehlers-Danlos Syndrome Mistaken as Abuse?

After Rebecca and her husband had their 5 children taken away with accusations of abuse, they started to fight for their children and the right to have appropriate actions taken. Rebecca asked the doctors to test her for anything that could be causing her daughter to have brittle bones. Rebecca’s determination paid off when she was diagnosed with [Ehlers-Danlos Syndrome](#). That gave her more drive to continue the fight to have her daughter tested even after their 5 children have remained in foster care.

Local Newspaper Picks up their Story

Appointment with Ehlers-Danlos Syndrome Set

The Wanosik family have an appointment with the specialist in Boston who saw Rebecca to determine if their daughter has the same diagnosis of Ehlers-Danlos Syndrome. Their appointment is set for July 6th at 1:30pm.

At this time the family is hoping they do not have to cancel their appointment, because they were told they have to make sure the caseworkers will be available to go on that date also. It has been decided it will be a 2 day trip to serve everyone's best interest. But Rebecca and Anthony feel it is the most cost effective for them to make it a one day trip since they are responsible for footing the bill.

"We are still required to pay overtime which potentially could include when the caseworkers are sleeping," states the family.

Wanosiks Still Fighting to Get their Children Back

This has been a long fight for the family, and they are finally allowed supervised visits from 9 a.m. to 8:30 p.m. daily instead of 9 hours a week.

While this provides some relief to the family, it still leaves them puzzled about the system.

The CPS circuit manager reportedly stated that she wasn't comfortable with unsupervised visits unless the parents acknowledged that the baby was hurt while in their care. The parents and their attorney refused to acknowledge something they did not do.

The family states: "Before they could entertain the idea of unsupervised visits they needed a signed release so the caseworker could access what had been discussed in the counseling sessions."

The Wanosik's sought out their own counseling courses, and now they are being told by CPS that they can't be sure they learned anything at these counseling sessions since they did not use the approved CPS teachers.

The family signed a release for their counseling session results 2 months ago, but their counselor has still not been contacted by CPS to check on the family's attendance or participation. Rebecca and Anthony attended *Love and Logic Courses* with a licensed counselor, and *Scream Free Parenting* at Army Community Services.

Even with all of this chaos, Anthony is still serving our country as he has been on active duty now for the last 6 years. Anthony and Rebecca remain strong and you can hear that in Rebecca's voice with [this radio interview](http://www.blogtalkradio.com/drjessarmine/2015/06/16/medical-kidnap-5-children-taken) they were featured on. Although the family is tired and works endless hours with research, phone calls, lawyer appointments and holding it all together, they have hope.

Unanswered Questions Remain

They still have many unanswered questions. During an evening with their new case worker, they were asked if they had any questions.

“We know there aren't any criminal charges so why is the state still holding my kids hostage over something that local law enforcement doesn't even have enough evidence to make an arrest over?”

According to Rebecca, there wasn't much of a response. She

continued to ask:

“Why don’t you have any other cases?” Her response was “I’m not an actual case worker, I’m at a supervisory level.”

The case manager then reportedly stated:

“[She] doesn’t have any other cases so she’s perfect for high profile cases like yours”.

Rebecca figures that because their story has been in the media, they are now classified as a “high profile” case.

Many families are enjoying their children this summer on family vacations and beautiful weather with picnics and family get-togethers. Rebecca and Anthony continue to fight for this nightmare to come to a close.

Medical Kidnapping in Missouri: 25 Year Old Daughter Forced onto Drugs and Committed to Mental Facility

A mother in Missouri has reached out to Health Impact News for help in getting the story of her 25 year old daughter told to the public. Donna Hitt from Columbia, Missouri tells Health Impact News that her autistic daughter, Chasity, started functioning at a high level after she weaned her off of psych drugs, and started feeding her an organic diet. Chasity had reportedly been confined to a hospital and heavily sedated, sleeping about 20 hours a day. After bringing her home, weaning her off of her drugs, and changing her diet, Donna reports that Chasity started functioning at a high level. She reportedly started contributing to household chores, attending church, and even applied for a job.

However, a social worker assigned to their case suggested that Donna should seek legal guardianship of Chasity, since Chasity is an adult. Donna says she followed this advice, and after the State of Missouri allegedly conducted a mental health evaluation of Chasity, they took over her custody against her will, and the will of her daughter. She is now confined to a mental facility, back on the same drugs she had previously suffered from, and is again sleeping away most of her days. Donna says she has not been able to talk to her daughter since October of 2014.

Here is her story.

Facing Adversity from an Early Age

At the age of 4 Chasity was diagnosed with PDD which is a form of Autism. Learn more about PDD here: <https://www.autismspeaks.org/what-autism/pdd-nos>.

An IEP was created for her through school to help assist her since she learned a little slower. Through the years her mother Donna was Chasity's coach. Chasity also had

scoliosis and her mom had Chasity take part in massage therapy, therapeutic horseback riding, physical therapy and swimming.

Mother's Love and Dedication Help Her Overcome the Odds

Doctors recommended Chasity be on medication to help with risk of seizures, and since Donna believed the doctors, Chasity stayed on several medications through the years.

Chasity continued to thrive with all the different therapies Donna was helping her do. The school determined they could no longer say that Chasity had PDD. In fact, Chasity graduated from school with honors.

A Bright Future Begins to Grow Dim

After graduation, Donna noticed that Chasity seemed to be reacting to her medicine. Donna says she asked the neurologist to please take her off the medication, but he allegedly refused. As Chasity's condition deteriorated, her mother watched in horror. Chasity became violent, and then lost all cognitive ability.

That year Donna brought her daughter to the hospital ER sixty times begging for help. Time after time nothing was found. Chasity wouldn't stop screaming. Donna knew her daughter was in pain. Donna continued to pray for help. Then she heard in her mind, "Have her stomach checked."

Searching for Answers to Stop the Pain

After many times at the hospital, hearing them say there was nothing they could do, Donna turned the car around

after leaving the hospital one day. The hospital insisted Chasity had lost her mind, but Donna says she demanded that they check her stomach.

Donna says it was then they discovered that all through her throat and stomach were ulcers. There was reportedly food in her stomach even after she had not eaten for 12 days. Chasity's bowels were full. It was evident her system was shutting down.

Condition Worsens while in Medical Care

More testing allegedly showed Chasity's stomach was only functioning at 50%. Donna explained to the doctors that she knew her daughter had an infection. She explained to them that every time Chasity had an infection when she was little, she would lose her ability to communicate. That is exactly what she believed was happening now. Donna was convinced all along that she was right.

Mother's Faith Keeps Her Strong in the Midst of Turmoil

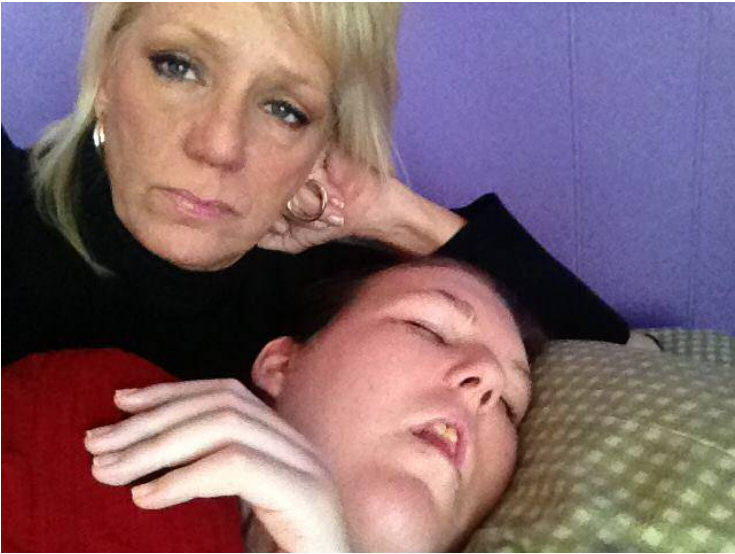

Donna thought now maybe Chasity would get some help. Sadly, she was mistaken.

Chasity was heavily medicated. She had no control of her bladder, she could not hold a fork or shower by herself. Her throwing up and constant screaming continued. Chasity's hair started falling out.

Donna realized that the only thing the doctors were doing was medicating her daughter. Anytime she wasn't medicated to the point of unconsciousness, Chasity would scream. It was so bad that even Donna had to put on headphones and listen to her teachings from God to keep her calm.

Before Donna knew it, there was an investigation on her saying Donna had Munchausen by Proxy Syndrome. They were investigating Donna because she was giving her

daughter Tylenol 2 every 4 hours to help with the pain. The investigation was reportedly quickly closed when they found no evidence to keep the case open. It became obvious to Donna that there was no hope for her daughter in the hospital.

Patient's Hypersensitivity to Medicines Ignored by Hospital Staff

After 2 months of living in the hospital, she left to drive her other daughter to school. When she returned, she knew something else was wrong with Chasity. After Donna had left the hospital, they reportedly gave Haldol to Chasity, and it dropped her blood pressure to 40/60. Donna says she had asked them not to give her a whole dose, knowing her daughter is hypersensitive to certain medicines.

Donna was shocked by what she saw when she returned. She yelled for the nurses, and when the nurses saw Chasity, they came running with heart monitors. An oxygen mask was also put on her daughter.

Daughter's Brush with Death Compels Mother to Continue Search for a Cure

Donna knew she had to get Chasity out of that hospital. Donna believed that her daughter's body would eventually give out and that she would die there. She made the decision to have her released from the hospital. Donna says she was scared, and felt very alone. But staying focused on Chasity's survival, she immersed herself in research.

Processed Foods Eliminated and Replaced with Organic Foods

Donna began to research food, and that's when she realized how hypersensitive her daughter was to processed food. If it was processed foods and things like gluten that would make Chasity's condition worse, Donna made the decision to not only be her caregiver, but also her lifesaver. Who knew Chasity better than herself, she reasoned. Who was better to be by her daughter's side and listen to what she knew she needed?

Donna pressed on by changing Chasity's diet. She started Chasity on supplements which included vitamin D, multivitamins, probiotics and iron. Organic produce and meat were part of her daily diet.

The Battle to Save her Daughter's Life Cost Her Retirement

Donna was not only battling to help her daughter, but they were living in a hotel during this time. Donna left her job to take care of her daughter and had to start over. She took out her retirement and got a beautiful hotel room for them to stay in where there was a kitchen and room for her daughter to heal.

Donna realized she needed some assistance so she could run errands and get to the store to pick up the foods that were healing her daughter. The State of Missouri granted her an aide that would come in and give Donna some relief to get a few things done.

A Miracle – Just in Time

Three weeks went by and then a miracle occurred. Donna heard nothing, there was silence. She realized that the nonstop screaming from Chasity was no more. Chasity had stopped mumbling to herself, and had started talking. She picked up her Bible and memorized a chapter. She listened to her music.

Tears of joy rolled down Donna's cheeks. Donna said,

“Chasity, what happened, where did you go?” Chasity looked at her mother and said, “I was confused mom. I was hurting and my stomach was sick.”

Rebuilding their Lives – Chasity Starts Functioning at a High Level

Chasity's life was turned around according to her mother. She continued to improve every day. She started asking her mom if she could vacuum the house. Chasity started going back to church, and they went out in public. Donna's sister was amazed by how much Chasity was talking, and the daily improvement was astounding.

Chasity started cooking and enjoyed the fresh organic foods. As Donna stated, “My daughter was healed with God’s healing properties in organic food. It’s living food!”

Social Worker Gives Advice

Donna bought a beautiful home. They moved in and said goodbye to the hotel that had been their stepping stone on this journey. The caseworker came in and was very pleased with Chasity and what had happened. She even remarked on their beautiful home that they just bought.

Chasity was functioning like a healthy young adult. Their home was complete and Donna thanked God for the miracles that had occurred.

Chasity had a job interview and was excited about it and discussed this with the case worker. The case worker was shocked to see Chasity getting a job and standing before her in wellness. She asked Donna to get guardianship for Chasity. Donna at the time thought that it would be a good thing, and her daughter was doing so well there was no reason to believe that anything else could go wrong.

State of Missouri Kidnaps Chasity

The day came where Donna went to get guardianship for her daughter and the caseworker came forward asking for a 30 day mental health evaluation on her daughter. Donna was against it, but realized she had no choice.

They never even asked Chasity or Donna to take the stand that day. The decision was made for her to have the health evaluation, based on previous hospital stays and not on Chasity's current health. Even though Chasity sat in that court room, she was allegedly never allowed to give her opinion. "Chasity was medical, not mental," Donna stated.

The State of Missouri took custody of Chasity and told Donna

she could visit once a week.

A Helpless Mother Cut Off From Her Daughter

Chasity would call and say, “Mom, they won’t let me out of my room.” Donna found out they were disciplining Chasity and her behavior, instead of looking at what they were feeding her and the medications she was being given. All Donna could do was listen helplessly.

They began to tell Donna she was hovering over her daughter and her visits were unhealthy. Donna has spent over \$60,000 in fees to fight for her daughter.

Forced Back to Drugs Against Their Will

They put Chasity back on the very medicines that were causing all her health issues. Chasity became unresponsive and slept for 20 hours a day.

Donna says it best:

“My daughter is one of these cases where conventional medicine didn’t help and the properties of healing foods did.”

After 6 months of Donna’s research and change of diet, Chasity had weaned herself off all her medications. Her body had thrived on nutrition. But now they had put her back on the same drugs.

Drugged to Sleep Her Life Away in State-run Mental Facility

Chasity is now 25 years old and sits in a state run mental facility. Donna sits outside many days and looks at her daughter's window. The shades are always drawn and her daughter never sees sunlight. Every time she calls she is told her daughter is sleeping. The last time she spoke with Chasity was October of 2014.

Unnecessary Surgery Performed

Donna was called to come visit her daughter one day and was told they needed to do surgery on Chasity. Donna had repeatedly asked for a hospital bed for Chasity like the one she had at home. Donna knew it would be better for her scoliosis, but instead she had a foam wedge that she lay on.

There was no chair in her room, and no movement out of the bed on a daily basis. The doctors stated that the surgery was needed.

Donna, being Chasity's forever advocate, tried to fight in court. She petitioned the judge, but he stated the paper work was not filled out correctly. They decided to insert 2 metal rods in her back. Donna was not allowed to see her after that.

Faith in Jesus Continues to Give Mother Strength

The last time Donna spoke to her daughter was after that surgery. Donna said, "Chasity, I am so sorry. They wouldn't let me come see you." There was silence and Chasity replied, "Mom, I saw heaven." Donna cried and said, "You did?" Chasity described the four angels she saw and described

Jesus. Donna knew it was God's way of helping them continue.

That was the last time she heard her daughter's voice. Not a day goes by where Donna doesn't think about Chasity.

Donna wonders how her daughter could have been taken for a 30 day evaluation and never come home. She wonders why Chasity was put back on the very medicines that were making her so sick, even after everyone saw how she turned around. Chasity had been enjoying her life, her new home and was looking forward to her future.

Urgent Help is Still Needed

It is a miracle Chasity's body hasn't given out now and she is still hanging on. Unfortunately, time is of the essence with Chasity, and every day could be her last.

Donna has a lawyer that has agreed to take the case. Donna wants her daughter's rights to stop being violated. Chasity thrived in her own home, and now she reportedly sleeps 17 hours daily on medications and injections. Her daughter loved to go to church, but now even her pastor is allegedly not allowed to visit her.

Donna misses her daughter with her every waking moment.

“They will not support her health through her diet which has been documented that helped her thrive, to bring her back to a normal life.”

After Parents Ask for Second Medical Opinion, CPS Destroys this Missouri Family

The trauma continues for the Jaxon Adams family. 8-year-old Missouri resident Jaxon was seized by Child Protective Services last September after his parents sought a 2nd opinion for his medical conditions. Now CPS has taken his 11 year old sister into custody, and Tiffany Adams is fighting to put her life back together and get both children back. According to Tiffany,

“When they take your kid, it destroys your life.”

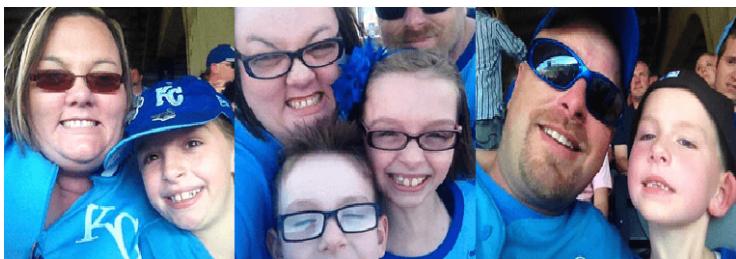
The Fight for Jaxon Adams Continues After He Was Taken by CPS When Parents Sought Second Opinion

At one time, the Adams family was a happy family. Jaxon had medical issues that they were trying to find answers for, but they were together, and there was a lot of love in the family. Since CPS entered the picture, their lives have been torn apart.

The Adams were forced to close their business that they ran out of their home for more than 7 years, and Tiffany has had to abandon her studies to become a nurse. She was only a few credit hours from becoming an RN, but the nature of the CPS allegations against them means that her hopes of becoming a nurse will not happen.

CPS Trauma Wreaks Havoc on Marriage

It is a story that we hear repeated frequently at Medical Kidnap – the stress and trauma of children being taken away and the controlling, endless “hoops” of the CPS service plans wreak havoc on the health and emotions of the entire family. The strongest of marriages is sorely tested, and some marriages don’t survive. All too often, someone within the system, whether counselor, social worker, attorney, or any of the myriad of people with their hands in the CPS pie, suggests to the parents, either covertly or blatantly, that their only hope of getting the children back is to separate or divorce. Parents, desperate to do whatever it takes to bring their children home, often comply, even though their compliance rarely brings the children home.

According to Tiffany, their situation pushed her husband Jason off the deep end. Tiffany attributes it to the trauma of their son's medical kidnapping.

“He was not like that before all this happened.”

Advised to Divorce in Order to Keep Her Children

During this very vulnerable season in her life, Tiffany reports that she was told that: “the only way I’d get Jaxx back was to leave Jason (her husband) ...” Not long after, the couple split up, and Tiffany moved out of the family home.

This is a post on the Bring Jaxon Adams Home Facebook page, dated 6/9/2015:

“I would like to give a Praise Report concerning Tiffany Adams. Please keep Tiffany and her family in your prayers. Tiffany has been subject to some extreme abuse and severe control tactics at a time in her life when she was most

vulnerable. She spent most of last night and the morning in the hospital for severe dehydration after being denied drinking water and food for at least 2 days while living in the above mentioned residence. She received 3 bags of fluids and is now staying in a safe woman's shelter. The truth about this entire story will come to the light. I would ask that all concerned about how children get taken from their families at a hospital's bidding and all the other Networks of people involved in that process, would continue to pray for the exposure necessary to put a stop to it. Jaxon Adams is thriving and doing well without all the medical treatment the Hospital (CHILDREN'S MERCY HOSPITAL) had initially prescribed. I publically [sic] thank our Lord, King, and Saviour Jesus Christ for hearing and answering prayer as I am sure many of you have been praying.

Child Protective Services Takes Jaxon's Sister

Tiffany reports that her daughter Hannah was recently seized by Child Protective Services. Her removal is partly due to an allegation reported to CPS that Tiffany was suicidal and held a gun to her own head in front of her daughter, an allegation that Tiffany says never happened.

Hannah is also allegedly said to be “at risk for medical abuse,” even though her mother says that she is in good health and has only been to the doctor twice in the past year. Hannah is reportedly having a difficult time emotionally because she is separated from her parents. She is staying in the same home as her brother Jaxon. Tiffany reports that her daughter is asking why she can’t come home, telling her mother:

“Mom, you never did anything to me!”

Jaxon is reportedly having nightmares about the day that he was taken away from his family and placed into state custody.

Tiffany Subjected to Pat-Downs for Visits

Visitation with her children is now only permitted at the courthouse or the police station. Tiffany says that they pat her down for all visits.

Trauma Taking a Toll on Tiffany's Health

Tiffany is now residing in a shelter for homeless and abused women, where she says that she is receiving counseling. She returned to the shelter Tuesday, July 14, after spending the previous 10 days at the hospital. She acquired a staph infection, possibly at the shelter, which made her sicker than she ever recalls being in her life. The infection caused a high fever and required surgery. During the course of the daily blood-work, doctors have found signs of an autoimmune disorder.

Tiffany was readmitted to the hospital the very next night with sepsis and low blood pressure. She hopes that they will be able to figure out what is going on soon. A bone marrow test is scheduled soon.

Caseworker Accuses Tiffany of Lying About Being in Hospital

There was a court hearing scheduled during the time that

Tiffany was confined to the hospital, but she says that the caseworker didn't believe that she was in the hospital and accused her of making that up.

This seems to be a recurring theme with CPS with regards to their case. Much of the family court case against the Adams was that a doctor at Children's Mercy Hospital accused the family of making up Jaxon's illness, saying that it was all in his head.

Next Court Date in August

The next court date is scheduled for August 24. This is to be a review of Hannah's case, as well as a hearing about contempt of court charges against Tiffany, based on Facebook posts.

Though the Adams were never issued an unconstitutional gag order, CPS has accused Tiffany of "endangering" Jaxon by posting information on the [Bring Jaxon Adams Home Facebook page](#). However, the page is not run by anyone in the Adams family, and they have no control over it. The posts in question were posted by an administrator, not the Adams. However, none of the posts ever mentioned where Jaxon was being held once he was released from the hospital.

Despite Everything, Tiffany Remains Hopeful

When Tiffany spoke with Health Impact News, she was surprisingly in good spirits. She has been through more than most, but she says,

"I believe God has a plan."

She is not giving up, nowhere near it. Even though the CPS case has shut the doors to her becoming a nurse, she is about to start a new job. She has to get her own place so that she can get her children back, and she is working towards that goal. Tiffany plans to go back to school in the fall and head in a different direction with her career.

Tiffany Adams says that she is doing everything that CPS is asking her to do, and has complied with all of their requirements.

“I cannot wait to have that feeling of ‘I won! I got my babies back!’”

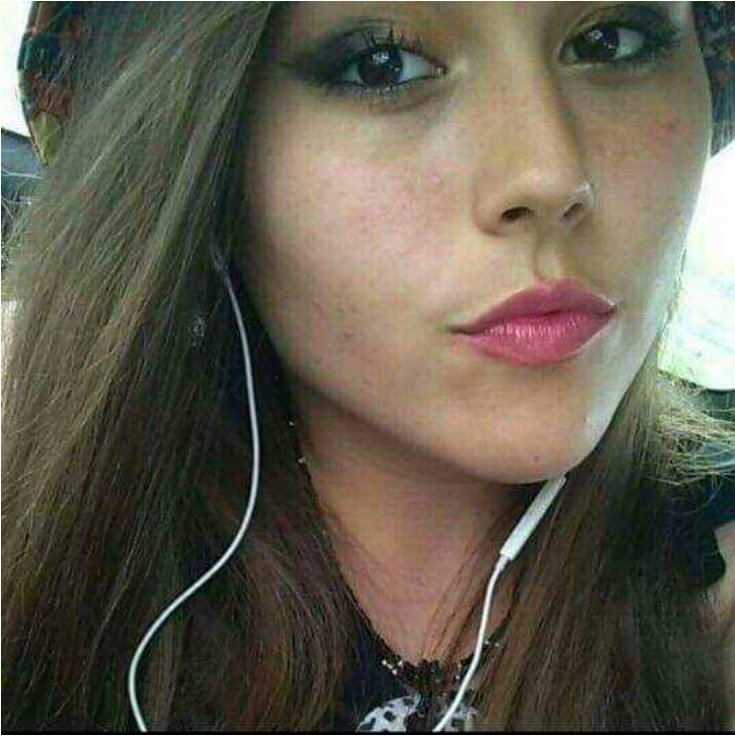

Native American Teen-age Girl Medically Kidnapped by State of Missouri

How does a teenager being held against her will by a man turn into her being taken from her parents by Child Protective Services and being held against her will in a group

home? How can a system allegedly allow such a man to make false reports to the police about the parents, and he is the one who goes free, while her parents watch in horror as police and CPS kidnap their daughter from them hours after they rescue her from her assailant?

The Daltons are members of the Children of the Four Winds Tribe, part of the federally recognized Six Nations, and they are fighting back legally in the courts. Leaders in the Six Nations have vowed to take this all the way to the Supreme Court if they have to. They claim injustice is happening to a Native American family, and their sovereign tribe is not happy.

According to the blog, “War on Corruption,” the first to address this story, it is “one that defies all logic, rationality, and law.” (Story [here](#) and [here](#).)

Their daughter just wants to come home, where she can feel safe again. In a letter dated October 12, 2015, KaSandra pleaded with authorities to hear her voice:

The best place for me right now is at home with my family, where they can protect me.

It All Started with an Argument Over the Teenager’s Cell Phone

KaSandra Dalton is 16 years old – pretty, smart, and athletic, and a fairly typical teenager in that she doesn’t always do what her parents want. Some guys dropped her off at her home on the evening of August 11, 2015, after she spent the night with one of her best friends. They didn’t stick around

to answer any questions when KaSandra needed assistance to get into the house. She told her mom that she hurt her leg playing soccer.

Rosemary and William Dalton, KaSandra's parents, checked her leg, but didn't find any swelling. Rosemary wanted her to go to their doctor to get it checked out, but KaSandra told them that she didn't need to go. She was texting on her phone while she argued with her parents. Rosemary reports that she wasn't acting right. She told her daughter to give her the cell phone, but KaSandra tried to hide it under her leg.

When her father got ahold of her phone, he was alarmed to find some inappropriate content, including messages that turned out to be from the 3 young men who had dropped her off earlier, injured. He tried to call the people she was talking to.

KaSandra was upset and went to her room. Her dad told her that he would take her to the doctor when she decided she was ready to go, while Rosemary headed to the store for a part to fix the plumbing issue she had been working on when her daughter came home. By this time, it was around 10:30 pm.

Teenager Goes Missing

Less than an hour later, William called his wife to tell her that KaSandra was not in her room – she was missing. Rosemary immediately headed home, and they called friends and 911. Officer Gresco of the Woodson Terrace police department came out to help search, but the Daltons continued to search after the officer left. William scoured his daughter's phone looking for clues. He took a couple of his sons and found the neighborhood where the car was that had dropped off KaSandra earlier that evening.

Found at a Man's House – They Beg Her Mom Not to Press Rape Charges

He went door-to-door asking for the owner of the car.

Around 4:30 am, he found the right house, that of Mohammed Cisse, an adult male, age 20. At first, they reportedly refused to let her out, but about 20 minutes later, KaSandra came out of the house crying. Mohammed's father came out to try to talk to William, but he refused to talk to him. He asked to talk with the mother, so Rosemary spoke with him on the phone. The first words out of his mouth were:

I am so sorry. I didn't know she was 16. Please do not press statutory rape charges against my son.

William headed home with his daughter, very thankful to have found her. They notified Officer Gresco, who met them at their house. He took KaSandra aside to talk with her. At that time she was walking on her injured leg, and told the officer that it wasn't hurt bad. She told him that her parents had yelled at her earlier, and that she had been mad about the phone.

Her parents later discovered that she had called a friend to pick her up after her mother left for the store. That friend told Mohammed, and Mohammed was the one who picked her up. KaSandra thought he was going to take her to her girlfriend's house, but he refused. Instead, he drove her around town, and into the next county, then back to his house. She said that she repeatedly asked him to take her home, but he refused, holding her prisoner against her will. She later referred to her father picking her up as him "rescuing her."

Her mother says that her daughter looked "shocked" and "traumatized." She had a look of shame about her, and gave off many behavioral indications of having been victimized.

But, Rosemary was never given the opportunity to try to help her daughter process what had happened.

Officer Gresco left the house at 5:36 am.

Her Attacker Calls Police on Her Parents!

One minute after Gresco left, a call allegedly came in at 5:37 am to the police reporting that a child welfare check was needed on KaSandra. The caller reported that her parents had abused her. The caller was allegedly Mohammed, who was parked down the street from the Dalton home, watching everything.

Five police officers showed up at the house, not including Officer Gresco. They didn't have a warrant, and reportedly became hostile when Rosemary asked for the warrant that she has the Constitutional right to demand. They had their hands on their guns, and there was screaming. The police demanded that KaSandra be taken to the emergency room at St. Vincent DePaul Hospital for medical care for her leg.

KaSandra had just been telling her mom before the police arrived that she didn't need to go the doctor, and Rosemary had just told her that she was going to take her to their doctor at 8 am, when their office opened. But the police allegedly wanted none of that, insisting that she go immediately, because they had a report that she needed medical care.

KaSandra Terrified When She Sees Mohammed Outside Her Home

When KaSandra looked outside, she “turned white as a ghost – terrified,” reports her mom. She saw Mohammed sitting

outside between two police cars. The frightened girl demanded:

THAT'S your source??

She had already been through a very traumatic night, and the officers were quite forceful in their demands. She agreed to go to the hospital as long as her mother went with her. Her mother's pleas to go to their doctor, who was a specialist, reportedly went unheeded. By that time, she says that she had figured out that it was an ACL injury, and she needed a sports medicine doctor.

They forced me to go against my knowledge on sports injuries and made me take her to an E.R. that was not a specialist which resulted in medical neglect on their part.

Doctors Ignore Parent's Requests

When they got to the hospital, Rosemary asked for 3 things from the E.R. doctors:

1. For them to examine her leg
2. A rape kit, because at this point, Rosemary didn't know what had happened to her daughter while she was missing, and
3. A psychological evaluation, because KaSandra was obviously traumatized after her ordeal

None of those things happened. Instead, at around 7:15 am,

the police called the E.R. doctor to tell him about Mohammed's allegations, ignoring the fact that Mr. Dalton had just rescued his daughter from the man. Over the course of the next few hours, Rosemary was forced out of her daughter's room. The staff was forbidden to tell her anything. They allegedly ignored everything that both Rosemary and KaSandra told them, instead, taking the word of her abductor.

Without a court order, CPS came in, and for the second time in less than 24 hours, KaSandra Dalton was kidnapped, and held against her will. Her parents were taken to the police

station and interrogated.

Medical Neglect? By Whom?

According to a police report, the police had been dispatched:

for a Check the Welfare of a juvenile that possibly had a broken leg and it was reported her parents were refusing to take her to the hospital and/or seek medical attention.

KaSandra had only been back in her mother's care for 23 minutes when the police came with that allegation. It was after 5:00 in the morning, and the doctor her mother wanted to take her to wouldn't open for another couple of hours. Yet, CPS alleged medical neglect on the part of the Daltons.

The E.R. told KaSandra that her leg was fine, that nothing was wrong. They did not do an MRI. Another doctor would later diagnose a broken tibia on September 3.

Later, on October 11, KaSandra was taken back to the E.R. The doctor there discovered that her leg never healed from the injury in August, and said that she should have been seen then by a sports medicine doctor and orthopedist, just as Rosemary had said from the beginning. She needs reconstructive surgery, but CPS is still not addressing this, even now. Her ACL is injured and her meniscus is torn. Rosemary reports:

The doctor said he can't see a break but her leg is now permanently damaged and [she] will never be able to play sports again. The Dr. also stated this was medical malpractice and medical neglect on the hospital, the E.R. ... the Dr. who

treated her and social services for not making sure she had proper care.

Additionally, KaSandra has been bitten by bedbugs, and has gotten lice and scabies – all from the group home that CPS placed her in. These have reportedly remained untreated.

What Actually Happened That Night?

It remains unclear exactly what happened the night that KaSandra tried to go to her best friend's house and Mohammed kept her from returning home. Instead of pressing charges, the police instead called CPS on the family. The hospital allegedly refused to do a rape kit after Mohammed made his false allegations against the Daltons, and police allegedly never investigated the incident. However, some things are very clear.

It was obvious to her parents that KaSandra was very frightened of Mohammed by the time her father found her. The 16 year old minor was allegedly kept against her will in the home of an adult, opening Mohammed up to charges of statutory rape and kidnapping.

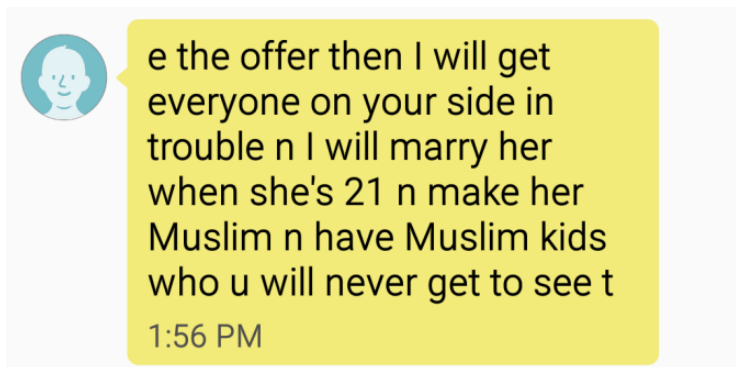
Mohammed sent some very brazen and disturbing text messages to the young lady and her parents after the incident, and they took screenshots. In one sent to KaSandra's father, he bragged that he took her virginity, actually using the word "took," implying non-consensual action:

... when I go to the courtroom I will not lie use this message do as u pleased we had sex I took her virginity ...

The Daltons are still unsure whether he actually raped their

daughter, or if this is simply very creepy talk.

In another series of texts with KaSandra's mother, Mohammed made some threats, including a vow to force KaSandra into marriage and "make her Muslim":

Stalked While in Foster Care – Even at School, But CPS Doesn't Stop It

KaSandra's attacker has not left her or her family alone since she was taken from her family. The Daltons are quite upset that Child "Protective" Services is failing to protect their daughter.

Rosemary reports that she met Mohammed in May, and that KaSandra knew him from school. However, a friend of the family who is part of the Muslim community warned them that they should stay away from Mohammed, because he was a "bad Muslim" who gives Muslims a bad name. Rosemary says that she learned that is code for "radical" or

“dangerous.” She told him then that her daughter was just 16 and that he needed to stay away from her.

Since the day of KaSandra’s abduction, he continued to text her and stalk her. The Daltons sent Health Impact News screenshots of numerous texts where KaSandra repeatedly told him to “Leave me alone.” He has threatened her, parked in front of her school several times waiting for her to come out, and called her all sorts of vulgar names. He has reportedly tried to run her brothers off the road and has thrown things at her house. Over and over, she has pleaded for him to leave her and her family alone, to no avail:

Weeks and weeks of telling him to leave me alone, that I don’t want to see him or talk to him.

On 2 separate instances, Mohammed reportedly tried to forcibly take her from her school. On September 24, he allegedly dressed in all black, sneaked up on her, and tried to grab her. Fortunately, her brothers and school security stepped in and stopped him. Undeterred, Mohammed allegedly tried again on September 30. This time her grandmother and other family members allegedly stopped him.

Why are No Charges Pressed Against Mohammed?

Despite confirmation from the school that he did this, CPS has refused to take steps to protect KaSandra from this man, and both CPS and the police have refused to press charges. All of this has happened while she has been in the custody of Child Protective Services and living in a group home. She

doesn't feel very protected.

In fact, when KaSandra's parents asked that CPS take out a restraining order, they refused. Even the school reportedly requested a restraining order, to no avail. So the Daltons filed one instead. The Deputy Juvenile Officer [DJO] reportedly wants it to be dismissed, and Mohammed has allegedly retained a lawyer over it. Yet, he continues to stalk and harass KaSandra.

One has to wonder – does he have an inside connection within the police department who is protecting him? Or could it be that, since the Ferguson riots, area police are reluctant to make any charges against a black man, even if the situation clearly warrants it? These are questions that people close to the situation are asking.

Rosemary reports that there may indeed be a racial element based on her family's Native American heritage. She says that the Chief of Police told her years ago that "We don't want your kind here."

Past Victimization of Dalton Family by CPS

Seventeen years ago, the Daltons had another encounter with CPS, one which didn't end well, and which also seemed to defy reason. Rosemary's 2 1/2 year old son broke his arm when his young cousins were trying to "help" him out of the car. She took her firstborn to the same hospital that the police compelled her to take KaSandra to 17 years later – St. Vincent DePaul Hospital. It is the same police department, and the same court.

The police investigation at the time did a full investigation, and they were ruled "exceptionally cleared." Yet, that did

not stop CPS from terminating all parental rights (TPR), citing that they “may have” abused the child. Some very questionable events occurred at that time:

- The judge in the case never actually heard the case. The case was heard by the commissioner. Yet the judge reportedly signed off on the TPR on June 4 – almost 3 weeks before the TPR hearing on June 20, 2000.
- CPS told Rosemary and William that they needed to divorce if she was to get her son back.
- Even the social worker and GAL at the time reportedly recommended reunification, because there were no grounds for TPR.
- [Dr. Dean Rosen](#), the psychologist who testified at the TPR hearing, stated that Rosemary was “too immature” to have her child returned home. This was based on the fact that the young mother, who was 8 months pregnant by this time with her 3rd child, wore a Mickey Mouse maternity t-shirt to her psychological evaluation, ignoring the basic psychological principle that parents matter to their children.

The Daltons never got their son back, until he became an adult. He was adopted by the foster family, who reportedly abused him, leaving him bruised from head to toe and beating him. He aged out of the system on August 25, 2013, and found his mother. He came home in September, and has been home with his biological family ever since. The family was finally reunited.

CPS seemingly did him no favors by taking him away from his family, yet now they are going after his younger sister.

Scholarship Opportunities up in Smoke?

Prior to Mohammed and CPS' involvement, KaSandra had a promising future. The high school junior has always had good grades, and is an honor student with numerous awards. She had been taking AP classes and college courses. She has been very involved with sports, and she was on track to receive scholarships for college.

Now, her parents wonder what will happen to their daughter's dreams. KaSandra wants to be an engineer, and needs scholarships for college. Since she has been in CPS custody, her grades have been slipping. The group home

allegedly forbids her access to the Internet to do her homework. She says that the facility is a “prison-like place.”

Allegations of Abuse Found Not True, So Why Isn't She Home?

Besides allegations of medical neglect, Mohammed also:

alleged abrasions, lacerations, blaming, verbal abuse, threatening, bruises, welts, red marks, and other physical abuse or injury.

This is according to a report from Social Services to Rosemary Dalton dated September 3, 2015. According to this report, investigators figured out that the injuries did not come from her parents, as alleged. The family has reported all along that all of her injuries happened with Mohammed. Her leg was injured playing soccer, but KaSandra was with Mohammed and her friends at that time, not her family.

The report concludes:

This case has been found unsubstantiated as the evidence does not support the allegations but preventative services will be put into the home.

Why? This make no sense to anyone in the Dalton family. CPS has refused to return her to her home, and will not even allow her to be placed with family. Despite the fact that there are “tons of family” willing to let her stay with them, the report states:

There has not been any family members approved for kinship placement.

Tribe Steps In – Finds Daltons Innocent

Because the Daltons are Native American, the Constitution provides them protected status. As we have found within a number of medical kidnapping cases, laws in the Indian Child Welfare Act (ICWA) have been ignored by the family courts. In a petition to the court, Rosemary Dalton testifies that she filled out the proper form for ICWA laws to apply, but:

*When I told Tiffany Lewis [social worker], (CD) that she **must** follow **ICWA** laws she said she **did not** have to because she is a social worker.*

Federal and state law make it clear that Lewis' alleged assertion is incorrect. She and the rest of CPS is required to obey ICWA laws; yet, they apparently have not.

The Children of the Four Winds, their tribe, is a tribe within the federally recognized Nation of the Six Nations. They claim that Social Services has acted outside of their jurisdiction. They have investigated the evidence and found the Daltons innocent of charges.

We as the tribunal have had already three hearings based on facts of evidence not lies by Tiffany Lewis [the social worker] nor cover up and concealed information from Sara Renschen [the DJO].

The Six Nations Prepared to Press Charges, Taking It to the Supreme Court If Necessary

The tribunal is demanding from the State of Missouri court that the minor child be returned to her natural parents. If this does not happen, they vow to:

press charges in the National Federal Supreme Court and will hold all individuals in Contempt of this Court Order will be punished under the Titles listed below.

These include charges against the DJO and CPS of Concealment, Conspiracy Against Rights, Deprivation of Rights, Ransom, Hostage Taking, and Neglect to Prevent.

Title 42 USC Section 1986 – Neglect to Prevent – Tiffany Lewis and DJO Sara Renschen does know that Mohammed has shown up at minor child’s school after school was out and tried to force minor child into his car. Any Judge with common sense would know that a 20-year-old male going after a minor child that is a female is trying to groom the minor for his own needs and wants. Making this 20-year-old male a sexual predator and should be listed as one.

How You Can Help

Rosemary Dalton has long been a strong voice for families. In February 2015, she founded [MAFA LLC](#) – Mothers Against Family Abuse – to help and advocate for other families who have suffered injustice at the hands of CPS. Last November marks the beginning of the fourth year that 70 year old Charley Taylor of Missouri has been held by Morgan County in a nursing home against his will, after a trip to the emergency room turned into a permanent medical confinement.

Although he has doctors who have stated that he is competent and of sound mind, and although his wife Helen had power of attorney to make decisions for him if he was medically not capable, a state-appointed conservator has been appointed to him by the court to make all decisions, even against his own wishes and the wishes of his wife.

Meanwhile his wife Helen, who has been fighting for her husband's freedom, has also been battling against false accusations herself. She has been sent to jail based on false charges and later released due to lack of evidence, kidnapped and confined to a mental hospital until a doctor determined that there was nothing wrong with her, and has been evaluated five times to prove her own competency. She told *Health Impact News*:

We were financially set for the rest of our lives after 40 years of marriage until I called 911. Our lives have been destroyed and I am told everything to do when I see him.

If this is justice, I don't need it. We want to be together. He is 70 years old, and I am 67.

I have never had but a speeding ticket in my life until the county took him from me. Since then, I have been labeled a thief, a person that blows up nursing homes, called in to take a lie detector for abusing animals. The county just won't stop with the things they accuse me of. I was a grandmother of 13. Now, I am a homeless woman that lives in an apartment across the street from my husband in a nursing home. Oh, I forgot, an abuser of my husband. No charges after 719 days in court. No witnesses. I can't believe what a crooked county can do to people.

Helen and Charley worked hard for many years for everything that they owned—sometimes working several jobs in addition to their full-time jobs. Helen said, “I’ve

worked all my life.” From 1979 to 2005 she was a field representative and managed doctors in medical facilities. She was so good at it that, she was sent across the country to open new facilities and train personnel. Additionally, Helen was also a mayor for two years in the town of Barnett, while also working a full-time job that required frequent travel, as well as a holding a municipal judge’s license.

The county has been depleting Helen and Charles’s joint properties. Helen refuses to part with any more. She said, “They are telling me to sell and they can split the money.”

Helen’s former attorney became very concerned for her safety. He asked:

“Do they know where you’re at? I’m worried for you.” He told her, “They will kill people for that amount of money.”

He advised her not to let those involved know where she is because they would rather kill her than be exposed and lose their income.

State Kidnaps Husband and Seizes Estate

Charley has asked for a jury to hear his competency case, requesting that the conservator be removed. This request has allegedly been denied.

Reportedly, to date, Amanda Huffman, who was elected in 2012 as [Conservator and Public Administrator for Morgan County](#), has drained a large sum of money and three homes from Charley's estate and has been pressuring Charley's 67 year old wife Helen to sell additional properties to pay for his care. (Health Impact News contacted Amanda Huffman but she has declined to comment at this time.)

Helen said that, despite being deemed competent in the eyes of the medical professionals, according to [Judge Kevin Schehr](#), the only one who is qualified to determine competency is conservator Amanda Huffman.

The Taylor Story – Living a Nightmare

Charley had limited mobility in his legs after a work-related injury in 1984. In November 2013, he was wheelchair bound, and as a result, he had two bedsores on his heels from his socks that would not heal. A neighbor, who was trying to be helpful, brought in an old heating pad without a cover, which Helen did not know about. The heating pad burned Charley, and then the burn would not heal.

Charley needed antibiotics, and the only kind that he could take was either injectable or given through an IV. When Helen spoke to Charley's doctor about it, the doctor told her to call 911 and have an ambulance get him to the emergency room.

The ambulance took him to the hospital where he was treated by a doctor. Helen said that doctor honed-in on Charley's fingernails that had been chewed off, accusing her of harming him. Reportedly, when Helen tried to explain that this was a habit that Charley had been living with all of his life, the doctor dismissed her.

Helen said that the doctor said that Charley had an infection and needed intensive surgery, lasting up to five hours. The doctor scheduled a surgery, insisting that Charley's condition was severe. To support their case, Helen was shown a photo of Charley's feet. However, Helen said, "They had somebody else's feet."

We had his toenails taken off because of sugar diabetes. The feet in the photo are smaller, and Charley wears a size 11.

She said, "They called me a liar."

Helen said that when the surgeon arrived to perform the surgery, he said that Charley did not have an infection. He said that he only needed a small procedure, lasting about 45 minutes.

Wife's Power of Attorney Removed – State Kidnaps Husband

While Charley was at the hospital, Helen was concerned for her husband. For instance, each day, for the first few days, when Helen arrived, she learned that Charley had been moved to a different location in the hospital. One day, she found him on a gurney by the elevator unattended, another day she learned that he had been moved to the oncology floor.

Helen visited Charley daily since his admission to the hospital. However, a couple of weeks went by where she was unable to leave her home because of illnesses. She had a bout with temporary blindness due to cataracts.



The following month, Helen and a friend went to check on Charley, and he was gone. Helen contacted her attorney to see about getting Charley moved. She said:

[He] called around, and he told me that Charley went to [a] nursing home.

He went on to say that on December 6, 2013 a petition had been filed by the Department of Health and Senior Services for Charley to have a conservator and a Guardian ad Litem. As a result, Morgan County Public Administrator Amanda Huffman was appointed as Conservator for Charley.

Helen was taken aback. At the time, she thought:

Surely, there has been a misunderstanding.

It was Helen who had durable power of attorney for Charley, and she was to make any decisions regarding Charley's medical care. According to Lawyers.com:

A conservator (sometimes known as an "adult guardian") is a court-appointed position responsible for managing the legal and financial affairs of an adult who is unable to manage these issues on his or her own.

Still in shock, Helen drove to see her husband and straighten out this misunderstanding. When Helen approached the nursing home administrator with questions about her husband, she was denied any and all information, citing HIPAA laws.

Another Nursing Home, Wife Forbidden to Kiss or Touch Husband

In January 2014, Charley was allegedly moved to Morgan County-owned [Golden Age Living Center](#), “The Home with a Heart,” in Stover, Missouri. Helen said that from the day that Charley arrived, she was told that she could not touch, kiss, or lay next to Charley anymore, and that her visits with him must be supervised by a staff member. (Golden Age Living Center has not yet responded to Health Impact News’ effort to contact them for comment.)

Helen bought Charley a cell phone since he did not have a phone in his room. There have been many times that Helen and other family members have called for hours on end, and the cell phone was turned off. She has resorted to calling the nurses station to try to reach him, and was told that she could not call them for personal calls. Eventually, the staff took the cell phone away. She was told that it was because the staff thought that Charley was taking photos with it.

She says she later found out that the nursing home staff had even blocked her number.

Husband Sexually Abused in Nursing Home

Helen said that there was one staff who “would touch and kiss” Charley. He did not like it. One day in July, Helen and Charley were on the phone. When the staff came in, Helen told him to lay down the phone so that they will think that he was off the phone.

Two CNAs came in, and then she heard another female voice that said, “Morning, Charley. Are you gonna smile for me today?” Then, there was total silence. “Charley, I know what will make you smile. Let me see that little pecker of yours.” Then, she said, “Girls, look at this little thing. Charley, you still aren’t smiling for me. Charley, are you gonna smile? Oh, I need to clean the dead skin off of that pecker.” Helen said that the she “rubbed and rubbed on it till the CNAs put a Depend on him.” She said, “Charley, you still haven’t smiled. Do I need to put her titties on your table to get you to smile for me?”

Helen said, “I was livid.” She asked Charley three times who the female voice was. She said that it took him a while before he would tell her.

Finally, he told her who it was.

Helen said about the nurse, “That was her thing—to get ‘em up. And laugh.” Helen allegedly immediately reported the incident to the social worker, but she said that it was never investigated. She said that the abuse continued for about three months, and then Charley called and made a police report. He made two reports about the nurse.

Helen said, “The nursing home told the attorney general that he was being treated for dementia, and the complaint stopped.” This was a lie, Helen said, because Charley’s doctors already said that he is of sound mind. Helen contacted the attorney general, but he refused to discuss it.

Helen’s attorney told her to take the sexual abuse information to police. When she did, she got a ticket for harassment. After three months of court hearings, she ended up with a \$225.00 fine.

Charley's Phone Listed On Dating Sites

Helen said that she traded phones with Charley and found that he had been listed on four dating sites and several shopping networks. She said, "Someone actually called the phone and asked for the nurse who had sexually assaulted him." Helen reported it to the administrator, but she said that nothing was done about it.

Wife Kidnapped from Home and Forced into Mental Hospital

After Charley was admitted to Golden Age Living Center, that night, not long after Helen went to bed, she heard a knock on the door. Next thing she knew, several men burst in the door. It was Morgan County police with an ambulance, stating that someone had reported that she overdosed on drugs. The ambulance took Helen to Calloway Community Mental Hospital, where she was told that she would be "kept for evaluation for 30 days." When she arrived, Helen was told by staff members that she was on lockdown 24-7 and "had to be in our line of sight at all times."

During her entire stay, Helen said that no tests or evaluations were done on her at the facility, including a drug test. She said, "I watched TV for 30 days." She constantly had Charley on her mind. She worried a lot about her husband, and expressed concern about him to those around her on a daily basis. He was her best friend, and she wanted to be there to ensure that he was being taken care of.

While Helen was there, she told a social worker that she needed to hurry and get out of there so that she could take care of Charley. The social worker showed compassion and made arrangements for Helen to speak with Charley by

phone for 30 minutes by phone every day.

One day, Helen approached a doctor at the facility. She asked, “What am I doing here?”

The doctor said, “I don’t know. Why are you here?”

She said, “I don’t know. Can I go home?” It was then that the doctor made arrangements for her release.

Helen’s Home Ransacked – Becomes Homeless

Helen was relieved and ecstatic about going home, especially because it meant that she would be seeing Charley again. However, her excitement was met with devastation:

When I got home the door was sawed off, and everything had been stolen and my home was ransacked. I had to walk away from the home.

The list of stolen items included jewelry, china, a dishwasher, clothing, and cash. Helen never recovered the stolen items. To this day, the police have had no leads, and no arrests have been made.

To add insult to injury, Helen said:

Later someone said they saw me kick the door in there—I’m 5’2” and weigh 107 lbs. They took me to jail again and let me out at 2:00 am. It was a 23 mile walk, a young man stopped on the road and took me twenty of those miles.

Helen Arrested – Falsely Accused of Making Terrorist Threats

During Charley's stay at Golden Age, Helen says she was accused of making terrorist threats after she was overheard talking with her grandson about a fundraiser for a skatepark on the 4th of July. Helen said that they talked about organizing a fireworks display, like she did when she was mayor. Reportedly, someone told authorities that they overheard Helen threatening to blow-up the nursing home. Helen was arrested, and her grandson was accused of being her accomplice.

The bail bonds man took my wedding ring as collateral for the \$50,000 bond. They've taken everything. They kept me in holding for 49 days. I paid a lawyer \$3000.00 only to find that he was seated on the board at the nursing home. They had two girls say that I threatened to blow up the nursing home. Their witnesses failed to show up in court for the hearing. The charges were dropped.

A social worker allegedly told Helen, "He's never coming home. You'll never see your husband again."

Helen said that a couple of days before she was arrested for the terrorist threat, a nursing home administrator allegedly said to her, "Your husband would be perfectly happy here if you didn't come and visit."

Helen Falsely Arrested Again – Then Quickly Released due to Lack of Evidence

One day Helen and her grandchildren were looking for

houses for sale near the nursing home, and she let her granddaughter let her out of the car to go into to see Charley. Helen drove down the street to look at the homes. When she returned, she was looking for her grandchildren. She said that a cop stopped her, saying that two CNAs reported that she had been parked in the back, attempting to kidnap Charley. She and her grandchildren were handcuffed and put in the police cars. She said that the children were unlawfully detained.

Dumbfounded, Helen said, “I told them, you may want to check your security cameras and see I wasn’t parked in the back parking lot.” Reportedly, the policeman said, “OK,” and released her.

Moved to Another Nursing Home in 2016

Last March, 2016, Charley was sent to a different nursing home, and he has been there ever since. Helen has been relegated to one hour visitation a day.

According to Helen, a few months ago, an administrator called a meeting with her. In that meeting, Helen was told that Charley would be evicted soon because Amanda Huffman allegedly has stopped paying Charley’s bill. Because of HIPPA laws, Helen does not know the billing amount or the account balance. However, she said that the bed alone is \$124.00 a day.

She said that Huffman is taking his retirement money from the railroad, and is now asking for his annuity. Helen told *Health Impact News*:

They told me sell some property. I already gave three houses away. Huffman signed off on the house and is putting the

[undisclosed amount] acres in my name.

Further, Helen said that Huffman is supposed to be sending her spousal support each month but has failed to do so.

Husband Allegedly Starving at Nursing Home

Helen brings Charley snacks on a regular basis because, without them, Charley would not have enough food to eat. She said he often tells her, “I didn’t get lunch today.” Also, she said that he goes without breakfast and lunch sometimes for a couple of days. Helen buys Charley clothing, food, etc.

I pay for everything at the nursing out of the [small monthly stipend] they give me to live. They don’t buy him anything.

When he is fed, it is not enough to fill him up, and it is difficult for him to eat.

Helen said, “The only time they take care of him is when I’m there.” Helen said that it is not uncommon to see that Charley’s Depends are on backwards, and he goes twelve hours without having them changed. She said that he has gone 19 days without a shower and witnessed a bandage on him that had feces on it.

Helen said that Charley “lays in the back room and has nobody to talk to.” Helen gets one hour visits daily. Amanda Huffman, who is in charge of Charley’s welfare according to the court, has reportedly only visited him twice since she was appointed conservator. Further, Helen said, “Huffman doesn’t return anybody’s calls.”

This is not worth the money she [Amanda Huffman] is wasting on this place—that I worked [for] all my life to take care of him.

Recently, she sought protection and help from an advocacy group for the state, which is in the beginning stages of involvement with her case.

How Could this Happen? Justice Denied

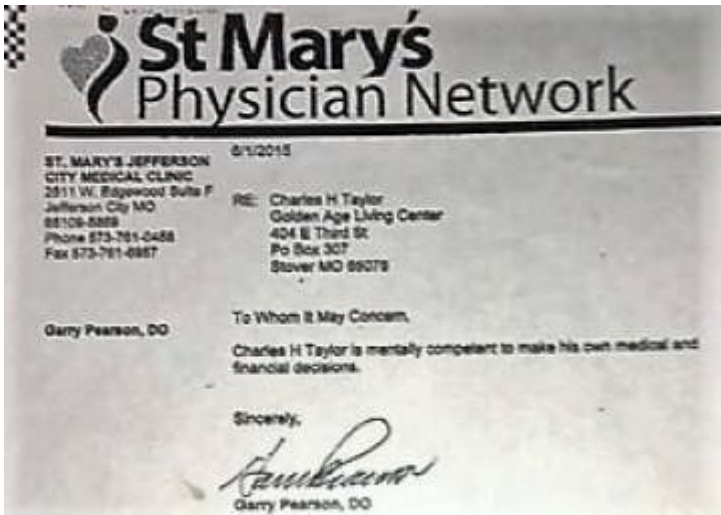
Both Helen and Charley feel that the conservatorship ruling is inappropriate and unjust, since Charley is able to handle his affairs. The couple have consulted lawyers and physicians to stop the abuse of power, as they are denied due process. The attorneys have stated that it is the burden of the court to show that Charley is in need of a conservator, which would necessitate a trial jury. Further, the court must also seek “next of kin and other interested persons” as potential conservators as a requirement to “meet due process concerns.” Reportedly, their pleas have been ignored by [Judge Schehr](#).

According to Helen, the day that the court-appointed lawyer brought it up in court, he quit. She said that it was never brought up again in court. Regarding all the corruption that is happening with their case, Helen said, “There ain’t no lawyer that can touch this.”

All we want is to be together.

This comes despite having documentation from two medical professionals. Both a psychiatrist and Charley’s medical doctor felt so strongly about the mishandling and misdiagnosis of Charley’s mental state that they wrote a letter on his behalf, stating that Charley is competent to handle his affairs. According to Helen, when the Taylors approached Amanda Huffman about this, she said that a doctor cannot make the determination as to whether Charley

needs a conservator or not.



Judge [Kevin Schehr](#) has said that medical evidence and a plan must be in place for Charley to safely return home. However, Helen said that nothing has been arranged or presented to the court to pursue this. Further, the judge said that Charley waived his right to a jury, but Helen said that the court could never produce evidence of such a waiver. She said, “There’s nothing on record.”

Attorneys Warn Helen

Since Charley was taken, Helen has dodged attacks on many fronts, which she believes were attempts to silence her. She says:

They have also tried to label me mentally incompetent, but it didn't work.

One of her attorneys told her, “They will kill you for this kind of money.” With regards to Morgan County’s judicial system, he said, “The Justice Center—it’s a joke. They make it up as they go along.”

Helen said, “There’s no justice there.”

How You Can Help

Helen and Charley want to bring attention to the devastation that they have endured, as well as others like them. For instance, there is another family in Missouri that has been suffering at the hands of the court system. Chasity Marietta has been held in a mental hospital against her will, and her mother, Donna, is fighting to bring her home.

Wife of Retired Couple Forbidden to See Her Husband in Nursing Home After Publication of MedicalKidnap.com Article

“Therefore what God has joined together, let no man separate.” That is a quote from the Bible that Helen Taylor has been holding on to for the years since her husband Charley was medically confined against his wishes and the

wishes of his wife.



It appears that an elected official in Morgan County, Missouri, has the power to keep apart the couple, no matter how much they want to be together.

Last week *Health Impact News* reported their story:

Husband of Retired Missouri Couple Medically Kidnapped – Estate Plundered to Pay for Unwanted Medical Confinement

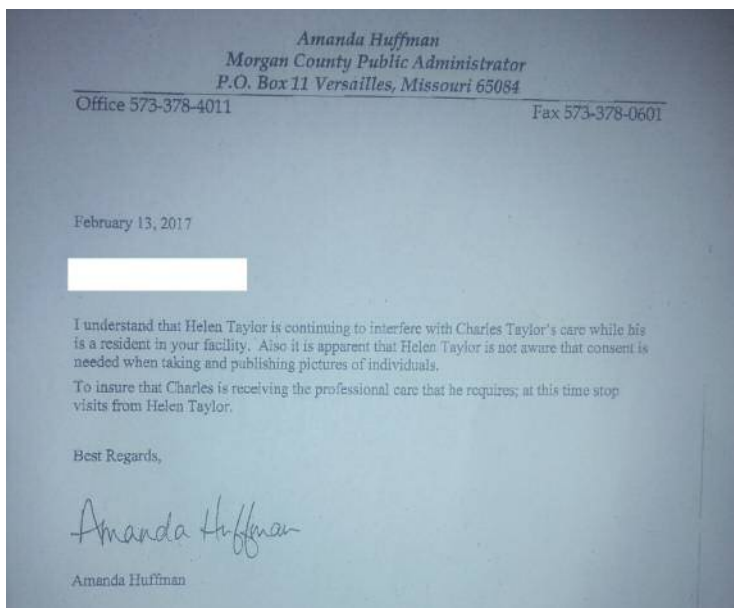
Shortly after our article was published, the day before Valentine's Day, Helen was told that she is no longer permitted to visit her husband in the nursing home, which is located in Callaway County, Missouri. Helen is devastated. She told us:

He is the love of my life. We just want to be together.

During Helen's visit with Charley Monday at the nursing

home, she said 2 nursing home employees told her that the administrator wanted to meet with her in her office. In that meeting, Helen was told that she was not allowed on the premises anymore. Further, if she returned, they would call the sheriff's department, and she would be arrested, according to Helen.

She was handed a letter signed by Conservator Amanda Huffman stating that Helen was interfering with Charley's care and that the nursing home was to stop all visits from her with her husband.

Even Charley's friends are reportedly being turned away from visiting him since Huffman's order. Later in the day on

Monday, a friend of the Taylors came to visit him. She was escorted off the property by three female staff members. She was told:

No one can come to see Charles Taylor without calling Amanda Huffman, and she has to approve it.

Helen said that visitors cannot call Huffman ahead of time, and that someone from the nursing home has to make the call while the visitor is present. Helen said that Amanda Huffman “doesn’t answer her phone.”

One issue that Huffman apparently had was that *Health Impact News* has published photos (copyrights of which are owned by Helen) of Charley without her permission.

Even though Amanda Huffman is legally Charley’s conservator (despite the wishes of both Charley and Helen Taylor), how is it possible that she could hold so much power as to forbid a wife to have photographs of her own husband?

Charley has consented to being photographed by his wife and by the couple’s friends. (Note: Helen had lots of photographs of Charley and of their life together, but the photographs also went missing when thieves broke into their home and stole everything of importance shortly after Charley was forced into his medical confinement.)

Charley Speaks with Health Impact News

In fact, Charley has made it clear that he wants nothing more than to go home with his wife.

One of our reporters spoke with Charley recently regarding the *Health Impact News* article and he verified that the article was true. The reporter found Charley to be very articulate and coherent.

When asked about allegations emailed to us that Helen had tried to hurt him, he was indignant:

That's nuts. My wife and I love each other very much!

Helen is very much afraid for her husband's safety. She has described numerous occasions when his care has been neglected, and she has made sure that staff took care of him properly. Without her checking in on him, she fears that he will not fare well.

Helen told us the nursing home staff sometimes leaves Charley's pants below his waist because "they don't want to go through the trouble of pulling them up." Also, she said that on Sunday, Charley got a shower for the first time in 14 days, after lying in bed for 19 hours with a wet Depend. She said:

Now they can let him lay for the rest of his life and not give him a shower, because I won't know it.

Helen is also concerned about the small amounts of food that Charley is served at the nursing home. She reports:

My husband's only being kept alive by the food that we take to him. Yesterday they brought him lunch – 4 teaspoons of

peas. An aide took the plate and walked out. She said, "I'll be right back." She came back in about 15 to 20 mins without Charley's plate.

She is afraid for his very life. She has many wonderful memories of their life together, and she wants to be there for him. Her wedding vows said they would stand together "till death do us part." How is it, then, that an elected conservator can violate their sacred vows and keep them apart?

Missouri Girl Medically Kidnapped Deteriorates in Mental Institution

For the past three years, 27-year-old Chasity Marietta has allegedly been languishing away at the hands of a state-owned mental institution in Missouri against her will while being robbed of her freedom, civil rights, and what her mother says is “her God-given destiny.”

Chasity says she is being held against her will and is suffering neglect. It has tested her faith in ways that most could never imagine, asking, “Why has God deserted me?”

Meanwhile, health problems and behaviors that were once eradicated have returned, and Chasity is allegedly medicated so much that she is only awake for seven hours a day. Her mother and fierce advocate, Donna Marietta, has been fighting to bring her home. She longs to see her daughter healthy and flourishing, as she was before the State of Missouri seized custody of her.

Almost two years ago, *Health Impact News* reported the story of neglect she has suffered in state care, as well as the subsequent decline of Chasity’s mental, physical, and spiritual condition since being taken. She is still not home. Donna speaks of the atrocities committed against Chasity as her condition continues to deteriorate to an unprecedented level. It is her hope that someone will do the right thing and intervene on Chasity’s behalf. She prays that help will come swiftly and turn this around before it is too late.

Here is the original story:

Medical Kidnapping in Missouri: 25 Year Old Daughter Forced onto Drugs and Committed to Mental Facility

When the story was published in June 2015, Donna had not seen her daughter since October of 2014. It was not until October 2015 that visitation resumed. Leading up to that, Donna said that in October 2015, she spent an entire day walking around her house in prayer, crying out to God on behalf of her daughter. The next day she received an email saying her daughter was requesting to see her. From there, she was granted one hourly supervised visitation a month.

Before Chasity was taken, she was in the process of getting a job and was very excited about it. She was vibrant, healthy, and was in complete recovery from her medical problems. With tenacity and patience, Donna went to great lengths and spent her entire retirement to research and acquire whole foods and supplements to heal her daughter. The protocol she implemented yielded remarkable results – a daughter who was fully-functioning and medication and seizure-free in her home. Donna said:

She was stable, in her right mind, experiencing health and healing.

However, in state custody, Chasity has allegedly been given food and beverages that have caused malnourishment and a resurgence of medical problems that were once obliterated, including seizures, crying, and screaming. Not long after being taken, Donna said that Chasity began “talking out of her head and running down the hall naked and screaming.” Donna said:

Chasity is suffering so much under their care. They took my daughter off of the lifestyle I had her on, according to Jordan Rubin, Ph.D., and according to what was working for Chasity in her diet.

Mental Institution Keeps Chasity from her Mother

Donna said that the mental institution is purposefully “keeping her out of my life,” and will not allow Chasity to see her family. Chasity’s family and friends have reportedly been denied visitation.

Donna longs to be more of a part of her daughter’s life. She is no longer privy to the day-to-day goings on in the life of her daughter. She said,

They won’t share with me the day-to-day, nothing. They’ve barred us from each other.

Additionally, Donna is not allowed to know exactly where Chasity lives, and since 2014, Donna has had to meet at a restaurant for visitation, with state workers looking on.

When Donna is permitted to visit her daughter, she is not allowed to take her cell phone in with her. Further, she cannot take photos, kiss or sit by Chasity, or share things with her. She is also restricted in the things that she can say around her daughter.

Donna said that Chasity needs the nurturing of her mother, including the nourishment for her body and spirit. The pain of witnessing the abuse and neglect of her daughter leaves her feeling helpless and overwhelmed. Sometimes, when she visits her daughter, it is all she can do to hold back tears. But, she said:

If I cry, they [staff and the state-appointed guardian] get up and leave, and take her [Chasity] with them.

Neglected, Starving, and Dehydrated

Chasity's healing protocol that her mother designed included vitamins, supplements, and a specific diet that requires meat. Meat was found to be vital to Chasity's recovery, specifically beef. Within the first week of going into the mental hospital, Chasity was taken off the vitamins, supplements, and her special diet.

Whenever Donna visits Chasity, she says that Chasity constantly begs her for food. Although it takes away precious time with her daughter, Donna will cut their visits short, telling the workers, "I'm leaving so she can eat." At one visit, the workers had given Chasity a snack that they said was her lunch. Donna said that it was a Lunchable that contained six pieces of meat product (containing no meat whatsoever), crackers, cheese, and pudding. She said that it was "a 25-year-old eating a children's snack," as the "320 calorie count in the entire package is not sufficient for someone her size."

Donna said that when she is with Chasity, "She begs her for food. It's all she talks about." According to Donna, the kinds of food that Chasity is given contains very little meat or vegetables, and is mostly processed frozen foods like potpies, Hamburger Helper, and Happy Meals, containing gluten. She frequently finds several happy meal toys in her purse. Chasity told her, "Hamburger Helper, we get that a lot. Sometimes I get meat in it." Donna said that the food they are feeding Chasity "doesn't support life and her health." She said, "The food is so devastating" that it causes Chasity to shake, a reaction from the food.

Chasity Subjected to an Impoverished Environment

Donna's heartbroken by the impoverished environment that her daughter is living in. Donna said,

It's poverty, and the deterioration is unbelievable. She went from size large to 2x. Her hair was beautiful. It was down to her waist. Now, it's short and always greasy. That was her

pride and joy. She dresses in the same clothes that are so tight, so short, and her socks are on wrong.

She said that her daughter now has “scabs on her head, filth in her ears, and they won’t help her shower.” She said, “She showers before she sees me, especially after what I put on Facebook.”

According to Donna, the constant foul language and erratic behaviors of the other residents affect Chasity. When she calls, Donna said,

I hear people in the background cussing at her calling her names. Chasity is now cussing.

She said that this has resulted in anxiety in her daughter as a response to her situation. When Chasity has expressed her frustration, she has been punished by having her visitation with her mother taken away for the month.

The last time that Chasity was able to communicate with her mother, she cried, “Mom, why would they take me from my family? I want to come home, Mom.” Donna said that since then:

Chasity has been unable to talk or communicate, including responding when spoken to or answering questions. She also cannot write. The abuse and neglect is inhumane, and she is crying out to me to get her home! This is horrific treatment of any human!

Further, according to Donna, Chasity screams and has seizures regularly, and can no longer make decisions for herself. She said that when they are together and Chasity has a seizure in front of her, Chasity is told to lie about it. Chasity told her:

Mom, [named staff member] said that I faked that seizure, and I'm sorry.

Chasity Regresses and Has Reverted to Past Behaviors

Donna said that at one time, “they locked her in 30 days and then sent her to a mental ward for 40 days where she received medication” that caused Chasity to have “unprecedented” behaviors and retarded her thinking. She said that Chasity was “unable to walk, talk, decisions, pick up a fork.”

She can't put her clothes on right, and they won't help her.

She said that one of those behaviors is screaming in pain due to gluten intolerance. She said that Chasity's digestive system is extremely sensitive, and gluten is one of the foods that causes her to react violently. Donna said that the painful episodes were eradicated while being cared for by her [mother], but “they have returned because no one is paying attention to Chasity's needs.” She said that Chasity is “talking out of her head and flicking her hair, scratching her neck until it's raw.”

Further, Chasity has been given shots to stop her periods. She sleeps continually and is “unable to stay awake because of the drugs.” Reportedly, she is being drugged to make her sleep – 17 hours a day. According to her mother:

They are medicating her so much, she can't get to the bathroom in time. She is urinating in her chair and bed, and she can't get up.

Family Persecuted for their Religious Beliefs

Chasity was raised in church, and she has consistently lived out her Christian faith. Donna said that Chasity used to be at church every time the doors were open. She loves reading the Bible, memorizing Scripture, and sharing the gospel, and it has devastated her to be removed from that lifestyle.

This is who my daughter is, but they won't let her be [who she is called to be]. They've taken that from her. The neglect and altering of my daughter's life has left her without being able to read her Bible or go to church.

Chasity is in a lockdown environment. She is not allowed to go anywhere, including church. Reading and standing on the Scriptures were keys to Chasity's healing, but in her current environment, Donna says, "She can't find Scripture."

They've taken that [ability to go to church] from her, and now she feels God has abandoned her.

Donna is concerned, not only for her daughter's well being but also her spiritual life. She has a sense of responsibility to provide a home for Chasity that aligns with her beliefs, a place that is consistent with her background and faith. Donna desires a "place of safety where she can eat [healthy foods] and go to church."

As a human being, that's her right.

From an early age, Chasity was taught the Scriptures, especially the ones dealing with healing. Donna has a degree in biblical studies and teaches healing at her church. Donna feels that she and her daughter are being persecuted for their beliefs.

She got it [healing], and they saw fit to take her. If I had been Amish, we wouldn't be in this situation.

Donna Coerced into Giving Away Guardianship

In the days leading up to Chasity being taken, Donna said that she was told by hospital staff and social workers several times that she should go to court to obtain guardianship of Chasity. Donna thought it was strange, because she thought that she already had guardianship of her daughter. Reportedly, when Chasity was in the hospital, the caseworker told her:

You really need to go get that guardianship because, if this happens again you will have the right to say what's going on with her.

Once Donna began pursuing it, she said:

The state showed up and said, 'We're taking her.' That was their way of getting me into court. The day I went to get it, the caseworker and the State of Missouri Department of Mental Health was there to stop me from getting the guardianship. I know when they took her, I was tricked by the caseworker by telling me to go to court to get guardianship of my daughter.

In court, Donna said that she was accused of Munchausen by Proxy Syndrome, though it was never pursued after the state

took custody her daughter. She said that recently, an attorney told her that he did not see a legitimate reason for her daughter to be taken away from her.

Medically Kidnapped Senior Citizen's Health Deteriorating in Missouri, Wife of 44 Years Forbidden to Help

It is going on four years since Charley Taylor has been held against his will in a nursing home under the control of a conservator. This is despite having two doctors say that he is competent. It has been a month since his wife Helen has

been banned from the nursing home, and the couple is heartbroken. Since that day, Charley's health has significantly declined, according to his wife Helen. Helen said that her husband has been "throwing up non-stop" since she was ordered off the premises indefinitely, or risk being arrested. She said:

He's as weak as a kitten, I can't hardly even understand him. When he talks to me, I've got to ask over and over what he said, because he's so weak.

Charley is bedridden, and reportedly, has been begging for a shower for 14 days. Helen said that Sunday night Charley finally got one because of an employee who has compassion on him. She said that he is still having to go up to ten hours without having his Depends changed. Helen said that Charley told her:

I'm tired of being in prison.

Helen told *Health Impact News*:

Prisoners at least see their families on Sunday.

On Monday, Helen received more devastating news. Charley told her that he is being moved permanently to a facility in Jefferson City, which is about 30 miles away. This is especially troubling because Helen does not have a vehicle. Since having their property and belongings plundered after Charley was taken, she does not have a vehicle and cannot

afford one. She has been renting an apartment within walking distance from his current nursing home. Helen longs to be near him, even if she is not allowed to see him.

Now, the couple can only speak by phone and are subject to arbitrary rules regarding it. Charley does not have a phone in his room. He has to use the one that is in the common area, and it is shared by residents and others.

Concerns About Not Enough to Eat

Helen is concerned now more than ever about Charley. She called the nursing home Sunday night to ask about Charley. She said that the staff member told her that he ate all of his breakfast and all of his lunch, and talked about “how good he was feeling.” However, afterwards Helen spoke to Charley to find that he did not eat well that day, and he was not feeling better. She told us:

He is so weak. He doesn't want to eat.

She said that one day last week, all he had was applesauce that was taken from him before he could finish it. Monday, all he had to eat was half of a biscuit and gravy and half of a grilled cheese.

He's so weak that he can hardly even talk. His health is going down. He's gone down so far. It's worse every time I talk to him.

She said that while she was on the phone with him, he had to have something to drink just to talk to her. She said that as he spoke, he would choke. She told him:

You're dehydrated. You need something to drink.

She said that Charley does not want the drinks that the nursing home gives him because of the laxatives they put in them.

She is concerned about his health:

He thinks it's his heart. He was doing this right before he went to have his stint put in. He was having a heart attack while he was throwing up, but he didn't feel it.

Since Helen was told that she was banned from the nursing home by his court-appointed guardian Amanda Huffman, she can only look on from a distance to see if she can catch a glimpse of what is going on there. She said that sometimes she sees Charley when the workers take him outside. *Medical Kidnap* reported last month that Helen was given a letter stating that she was no longer allowed to visit her husband because she was interfering with his care.

Recently, a nurse showed concern for Charley's condition. Helen said:

The nurse asked if I knew of anything that he would eat or drink. I told her, 'You can tell that he's dehydrated because he needs something to drink to talk to me on the phone.'

When Helen was still able to visit Charley, she would take him food and drinks on a regular basis to ensure that he would have enough to eat and drink, and he would keep the items in a drawer by his bed. She said that a while back, she brought him a big bag of fruit, peanut butter and crackers, etc. When she did bring him such things, she said that the staff would only dispense him a few items at a time. Helen said that Charley told her that the only thing that he got from that delivery was the peanut butter and crackers. Helen said:

I don't know where the rest of the food goes. Huffman says they're choke items. She said [that] I'm trying to choke him. Before, it was [that I was] starving him. He can't chew a lot of things because of his teeth.

Pain Medication Allegedly Stolen

Helen said that there is a certain worker who is stealing his medication. Helen said that a worker is writing in his chart

that he is taking one pill for pain every four hours. But, Helen said that he only takes them as needed.

This was uncovered about three weeks ago, Helen said, while a nurse was reading his chart. The nurse remarked to Charley that he had been taking a pill every four hours. At that time, it was 11:00 pm, and Charley told her that the last one he had was at noon. Helen said that Charley told the administrator and was told that they would investigate it.

Health Impact News spoke to Charley about this recently. He said:

Yeah, I think they got rid of her. I don't know if it's true or not. But, that's what I heard. She was definitely helping herself. That ain't right.

Charley Allegedly Prevented from Talking to Attorney

Helen also said that the lawyer from the advocacy group has called to speak with Charley three times. She said that the first two times, the staff member put another resident on the phone instead – a man who was described as “sounding incompetent.” Helen said that the lawyer told her:

Mrs. Taylor, I don't think your husband knows who I am or what I'm doing for him.

Helen replied:

What?! Not my husband. And, besides, he would have told me if you had spoken to him.

According to Helen, when the lawyer did finally speak with Charley, she said:

Well, he doesn't know who I am. This man is a lot more vocal than the man I talked to last Friday and the week before.

Helen said that it was because it was the first time that she had actually spoken to Charley. Helen said that the lawyer told Charley:

You were more vocal than the last time.

Charley replied:

That's because that wasn't me you were talking to. Because, this is the first time you've talked to me.

Reportedly, the nursing home documents state that they are recommending that Charley not be released into the community and that he continues to not understand questions being asked to him. Additionally, Helen said that it has taken a federal subpoena to get the nursing home to send Charley's medical records to the advocacy group's office since being requested in November. Helen said that the lawyer told her that they were received last week.

Helen, herself, has had trouble speaking to Charley by phone. Recently, when she called, Helen was told by four different people at the nursing home:

He isn't getting up, and he doesn't want to talk to you.

However, when she did finally speak to Charley, she asked him about it. He told her that they were lying about him not wanting to talk to her.

He told me, 'No. I told you I'd call you.'

Charley Prevented from Seeking Justice?

Recently, Charley spoke with Helen by phone and described a visit that he had that morning from two women. He specifically said that one of the women said that her name was Rhonda from the Ombudsman office. He opened up to the women, telling them all that was happening to him. He explained to them that he felt that he was being held prisoner.

However, when Helen called the Ombudsman office on Friday, Rhonda Giger said that she was not even in Morgan County at all that day. Later, *Health Impact News* spoke with Ms. Giger, and she confirmed that no one from her office had visited Charley yet.

Helen wants to know who it was that visited Charley. She pointed out that the visitors, whoever they were, must have been given access by his conservator. All visitors must be approved by his conservator. *Health Impact News* called the

nursing home and spoke with Cynthia, an employee of the nursing home. The reporter asked if she could verify that it was the Ombudsman office that came to see him last Thursday, and she said:

No, I cannot.

Helen said that she spoke to Ms. Giger about her being banned from the nursing home. She said that Ms. Giger told her that what they are doing is illegal, and Helen has every right to see her husband. Further, according to Helen, is it the nursing home administrator who is keeping her away from Charley, not the conservator.

Health Impact News asked Charley:

Do you think the Ombudsmen have been helping you?

He responded:

I ain't seen help. Ain't nothing changed for years. I'm getting tired of it. Nobody listens. Nobody can tell the truth. They lie every other breath. That's all they do. Do you think this [publishing this story] will ever help? Am I ever gonna get out of this place? What do you think?

Charley's Health Deteriorates

Recently, during a routine doctor visit, Charley was allegedly sent to the emergency room for dehydration and a urinary

tract infection. He said:

I haven't had an appetite for three weeks. I can't eat. I'm throwing up.

He said that he told the doctor that he had not had a bowel movement for 18 days, but the doctor did not offer any help. Charley said:

They wouldn't listen to me. I think it's my heart, 'cause I've been [feeling this way] before. And the last time, I had to get two stints in my heart. I couldn't eat. I'd throw up every time I tried to eat. That's been going on for three weeks.

Helen said that the nursing home had been giving Charley oral antibiotics intermittently since being admitted. She pointed out that he is not supposed to have oral antibiotics. He cannot tolerate them. She said that they make him sick to his stomach.

Health ImpactNews spoke with Charley on Friday about this, and he confirmed that he had been getting oral antibiotics. However, he said:

They gave me a shot last night. Finally! Finally, they gave it to me—a shot. Right about one in the morning. They were trying to give me pills. I wouldn't take them because they hurt me inside. I just refused, and they finally gave me a shot. So, maybe I'll get shots [from now on]. That would be a miracle! That would be wonderful. I've got a UTI, and I'm gonna get rid of it. I got a shot! So, that's taking care of it.

Being Kept from Helen Devastates Charley

Helen said that being denied visitation has especially been devastating for Charley. Seeing his wife was the highlight of his day. He told *Health Impact News*:

I'm just an old grouch right now. I'm not happy here. I'm not happy! This is hell!

When asked how he felt about being apart from his wife, Charley said:

I hate it! I hate it. I'd rather be dead than be doing this. I want to see my wife. I want to go home where I belong. That's where I should be. How would you like it if you couldn't see your better half? It's horrible. It ain't right! It's gotten worse. I ain't seen my wife for over a month. They won't let me see her. They accused her of interfering with my care. What care?! Bull! Bull! And, what they accused her of, she didn't do. She's innocent. They lie. Everything out of their mouths is lies. Everything! Oh, well! It's somethin' else. I'm afraid they're gonna drive my wife crazy with their lying.

Charley Begg for Help

Health Impact News spoke to Charley about his living conditions. He said:

My roommate stinks so bad you can't breathe in there. I mean, it's terrible. He's been that way all day. I don't know if they're ever gonna clean him up or not.

Helen confirmed that Charley could not stand to be in his room because of the smell.

Charley told *Health Impact News*:

My wheelchair is breaking my back, and they won't give me a different chair. I don't know why. I think they want me to suffer a little. I don't know why.

Charley is begging for help. He told *Health Impact News*:

Get me outta here. Do it! Don't hesitate! I aint gonna make it if I don't get out of here. That's the truth. I want out here! I am gonna go nuts if I don't get outta here. Yeah, that's the truth. I'm desperate! They've just about got me, I think. I'm desperate! Desperate! Please!

Children's Mercy Hospital in Missouri Medically Kidnaps 10-Year-Old Girl because Parents Wanted a Second Opinion

Children's Mercy Hospital in Kansas City, Missouri, has struck again, allegedly kidnapping a 10-year-old girl from her parents simply because the parents questioned her treatment and use of a questionable drug that allegedly caused their daughter's brain to swell (encephalitis). The parents reportedly did not refuse treatment or go against the doctor's advice, but simply wanted to take their daughter to a different hospital to get a second opinion.

The doctor refused, had security guards intervene to stop them from taking their daughter home, and now the State of Missouri has taken custody of the child giving them full legal liability-free rights to experiment on her with whatever drugs they want, without getting the parents' permission.

Over the years we have covered multiple stories of medical kidnapping involving Children's Mercy Hospital in Kansas City which has now apparently become so routine, that a Missouri State Senator has introduced a new bill to stop the hospital from kidnapping people's children.

Here are a couple of our previous stories about Children's Mercy Hospital in Kansas City:

Earlier this year (2022), Missouri State Senator Mike Cierpiot

introduced a bill to protect families from having their children “abducted by Children’s Mercy Hospital.” The Missouri Times [covered the story here](#).

Excerpt:

For Cierpiot, the matter is personal. From the floor, he discussed his own family’s struggle with a Children’s Division that he said gave far too much power to hospitals, such as Children’s Mercy in Kansas City, over the fate of Missouri families.

He recounted how after a day of shopping last year, a new mother took her baby out for the first time. While adjusting the car seat straps the newborn developed a bruise on its side, and the parents likely overreacted by taking the child to the hospital “just to be safe.”

It was then that Children’s Mercy got a SAFE-CARE provider involved. After viewing some photographs of the child’s bruise, a doctor diagnosed that she “suspected signs of child abuse.”

After two days of bringing both of their children in for X-rays and exams, doctors only found the one bruise on the one child and no abuse on the other child. The next day, child welfare services showed up with law enforcement officials to take the newborn from his mother’s arms. ([Full story](#).)

Here is a 9-minute video of his explanation of the bill given in the Senate Committee, where he relates how the abuses of Children’s Mercy Hospital have affected his own family members where a 3-week-old infant was medically kidnapped and taken away from the parents for 3 months,

and how when he contacted several local attorneys, they stated that they have created a phrase about Children's Mercy Hospital:

The term is "abducted by Children's Mercy Hospital."

Imagine that. It's a real thing. "Abducted by Children's Mercy Hospital."

SAVE EVELYN: Little girl taken by controversial hospital

Evelyn Young was medically kidnapped by Children's Mercy, a prestigious research hospital in Kansas City, after her loving parents demanded a second opinion.

A research hospital has been medically kidnapping children for years. Children's Mercy Hospital's most recent kidnapping happened just a couple of weeks ago when the Young family brought their 10-year-old daughter Evelyn to the doctor for medical advice and support.

Instead of giving what Evelyn's parents considered appropriate medical care, the hospital gave her medication that allegedly turned Evelyn's mild health condition into a severe issue. After this treatment, Evelyn's brain began to swell, causing her to temporarily lose consciousness and her eye sight.

Her parents were understandably upset and angry at the hospital, and explained they wanted to take their daughter to a different hospital. Instead of allowing the family to leave, the hospital used the parents' anger and frustration as "proof" that they are unfit guardians.

Children's Mercy called Child Protective Services, and just like that, Evelyn's parents were no longer in control. As bizarre as this sounds, the hospital is known for tearing families apart. The hospital facilitates the taking of parental rights so often that a local legislator introduced a bill that would stop them from engaging in these anti-family practices.

"They've torn so many families apart. Just for being concerned about their children," Jessica Young told me. "And I complied with everything they did to my daughter because I was aware of the leverage they held over my family... compliance wasn't enough — I also had to believe

in what they were doing.”
